The TRIAL PANEL II FINDS that the following highlighted text contains confidential information and ORDERS this information shall be removed/ edited from the PUBLIC broadcast/streaming, audio visual recording and transcripts in all three languages *Albanian/ English/ Serbian*. Hearing 4 November 2021, transcript reference Page 137 Line 6 (time code 15:41:59), Line 10 (time code 15:42:15), Line 12-13 (time code 15:42:23 – 15:42:26), Line 17-18 (time code 15:42:40-15:42:43), Line 21 (time code 15:42:55) and Line 22 (time code 15:43:01):

137:1 And I will read from the e-mail, which just for everyone's ease of 15:41:37  
2 reference is on 14 October at 4.21 in the afternoon. It states as 15:41:40  
3 follows: 15:41:46  
4 "Following the distribution of the batches, SPO witness security 15:41:46  
5 took measures in the field. Such measures included one relocation, 15:41:52  
6 moving someone to [REDACTED], and referring persons to witness 15:41:59  
7 protection." 15:42:03  
8 Mr. Witness, does this sound accurate in terms of the 15:42:06  
9 information you provided to the SPO. Specifically, here we're 15:42:09  
10 talking about one relocation and someone being moved to [REDACTED]? 15:42:15  
11 A. Yes, that's correct. Two persons. 15:42:18  
12 Q. And just to be clear, Mr. Witness, in terms [REDACTED] 15:42:23  
13 [REDACTED], are you distinguishing that from a relocation, or is it 15:42:26  
14 essentially the same thing? 15:42:30  
15 A. It's the same thing. 15:42:35  
16 Q. And could you explain why, at least as reported in this note, 15:42:36  
17 you did distinguish at one stage between one relocation and [REDACTED] 15:42:40  
18 [REDACTED] Is there any difference that you can think 15:42:43  
19 of if there is any and if relevant? 15:42:48  
20 A. The relocation we did was direct -- directly person was 15:42:50  
21 extracted out of the Kosovo moving in the [REDACTED] Person was 15:42:55  
22 extracted from their home to the [REDACTED], and afterwards extracted 15:43:01  
23 out of the Kosovo. 15:43:04
