I. INTRODUCTION

- On 2 December 2021, the Defence for Mr. Haradinaj filed its List of Exhibits pursuant to Rule 119(2)(b) of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers ("Rules").¹
- 2. On 2 December 2021, the Panel ordered both Defence teams to file an updated exhibit list conforming to paragraph 60(e) on the Order on Conduct of Proceedings by 6 December 2021.² On 8 December 2021, the Panel granted an extension and ordered the Haradinaj Defence to file their updated exhibit list by Friday 10 December 2021.³
- 3. On 10 December 2021, the Haradinaj Defence filed an updated exhibit list and requested to add the exhibits listed in the Annex 1 to the filing.⁴
- 4. On 15 December 2021, in an Oral Order,⁵ the Trial Panel, in accordance with Rule 119(5) and noting that the Specialist Prosecutor's Office ("SPO") did not object to the addition of the new exhibits listed in the Haradinaj Defence in the attached Annex, ordered the Haradinaj Defence to file an updated consolidated exhibit list by 6
