## I. **SUBMISSIONS**

- 1. In accordance with the Order on the Conduct of the Proceedings (the "Order"), Rule 144 of the Rules of Procedure and Evidence, and Registry Practice Direction KSC-BD-23, the Defence for Mr Gucati hereby submits a request that testimony be provided via video-link for at least two of its witnesses (the "Application").
- 2. Pursuant to Rule 119(1) the Defence are entitled to wait until a decision pursuant to Rule 130 before deciding whether a Defence case will be presented. The Defence has not decided which witnesses, if any, it will call. However, the Defence appreciates that in the event that it does call witnesses, and they request to give their evidence via video-link, the Registry will need adequate time to organise the video link facility.
- 3. On that basis, the Defence has considered its position and notifies the Trial Panel and the Registry that there may be two witnesses that if called would give evidence via video-link.
- 4. The Order states at paragraph 57:

"The presenting Party shall provide the Registrar and the Panel with the information required by the Registry Practice Direction (the "Practice Direction") on Video Links (KSC-BD-23/COR)"


