## I. INTRODUCTION

- 1. The Haradinaj Defence hereby submits an application under Rule 82 (5) of the Rules of Procedure and Evidence for the reclassification of its *Defence Submission* for *Detention Review* of 16 December 2021<sup>1</sup> from confidential to public.
- 2. On 21 December 2021, the Trial Panel issued *its Decision on Review of Detention of Nasim Haradinaj*<sup>2</sup> which ordered the continued detention of Mr Haradinaj and requested the Haradinaj Defence to submit a public redacted version of its application for Detention Review of 16 December 2021<sup>3</sup> by 24 January 2022.
- 3. In its Oral Order of 28 January 2022, the Trial Panel reiterated its instruction to the Haradinaj Defence to file a public redacted version of its *Defence Submission for Detention Review* of 16 December 2021,<sup>4</sup> following the redactions applied by the Trial Panel, by 31 January 2022.<sup>5</sup>
- 4. Having reviewed the redaction regime applied by the Trial Panel in its *Decision on*\*Review of Detention of Nasim Haradinaj,6 the Haradinaj Defence notes that the information expunged relates to the details of the mitigating measures proposed
