Prosecution Response to Haradinaj Defence Reclassification Request

- 1. On 21 December 2021 and 31 January 2022, the Trial Panel directed the Haradinaj Defence to file public redacted versions<sup>1</sup> of the Haradinaj Detention Submission.<sup>2</sup> In requesting reclassification of the Haradinaj Detention Submission,<sup>3</sup> the Haradinaj Defence has not complied with the Trial Panel's directions.
- 2. Contrary to the Haradinaj Defence's submission, the Haradinaj Defence did address non-public matters in the Haradinaj Detention Submission.<sup>4</sup> To cite one prominent instance, specific individuals named by way of example in SPO submissions have been duly redacted in the SPO and Gucati Defence detention submissions, and the Trial Panel considered these materials in a way careful not to reveal any names.<sup>5</sup> However, paragraph 18 of the Haradinaj Detention Submission reveals the same names.
- 3. It is requested that the request for reclassification of the Haradinaj Detention Submission be rejected, and the Haradinaj Defence be (again) directed to file a public redacted version.
