1. The Specialist Prosecutor's Office ('SPO') hereby replies to one new issue¹ raised in the Veseli Response,² namely, the Defence request to order the SPO to disclose SPOE00297872-00297878.³
2. As previously indicated,⁴ the SPO does not intend to rely on SPOE00297872-00297878. SPOE00297872-00297878 is listed on the Rule 102(3) Notice⁵ and has been requested by other Defence teams. In that context, the SPO is taking appropriate steps, including ongoing consultations with the provider.⁶ Accordingly, the SPO will treat the Veseli Defence request for disclosure of SPOE00297872-00297878 as a request under Rule 102(3) and will disclose the document in due course.
