1. Pursuant to Rule 95(4) of the Rules<sup>1</sup> and Article 27 of the Practice Direction,<sup>2</sup> the Specialist Prosecutor's Office ('SPO') hereby files a corrected version of the Pre-Trial Brief ('Corrected Brief').<sup>3</sup>
2. In addition to the corrections made, the SPO has also reviewed the redactions applied to the confidential version of the Corrected Brief.
