1. The Defence for Mr Kadri Veseli ("the Defence") hereby joins the "Thaçi

Defence Motion for an Independent and Impartial Review of Exculpatory

Material"1 filed 7 March 2022; and the "Krasniqi Defence Request for a Finding

of Disclosure Failure, Setting a Disclosure Deadline and Appointment of an

Independent and Impartial Magistrate"² filed on 11 March 2022.

2. The Defence is affected by the same issues raised in the Thaçi and Krasnigi

Defences Requests. The Defence further agrees with the submissions presented

in the Thaçi and the Krasniqi Requests; namely, that the SPO has not respected

its obligation under Rule 103 by not disclosing exculpatory material "as soon

as it is in his or her custody, control or actual knowledge"; and that the SPO's

withholding of exculpatory material and delayed disclosure thereof has

unfairly prejudiced the Defence.4

3. The Defence agrees with the relief requested by both teams, requesting the Pre-

Trial Judge to: (i) find the SPO in the violation of its obligation under Rule 103

to disclose exculpatory material immediately; (ii) appoint of an objective third

party to review and disclose exculpatory material (iii) set a deadline for the SPO

to complete its Rule 103 disclosure.⁵

Accordingly, the Defence hereby joins both the Thaçi and Krasniqi Requests 4.

and the relief requested therein.
