1. On 22 September 2021, the Specialist Prosecutor's Office ('SPO') submitted its supplemental Rule 102(3)<sup>1</sup> notice.<sup>2</sup> On 13 January 2022, the SPO submitted a revised supplemental Rule 102(3) notice containing amended descriptions and items which could not previously be listed due to Rule 107 restrictions.<sup>3</sup>
2. On 4 March 2022, further to an *inter partes* request by the Defence, the SPO informed the Pre-Trial Judge and the Defence that it would review its Rule 102(3) notice and revise the descriptions of the items contained therein, where deemed necessary.<sup>4</sup>
3. Having completed that review, the SPO hereby files its further revised Rule 102(3) notice.<sup>5</sup>
