1. Pursuant to Rule 26(1) of the Rules,<sup>1</sup> the Registrar hereby informs the Pre-Trial Judge of the approval of Co-Counsel for victims participating in the proceedings.
2. On 27 January 2022, the Registrar assigned Mr Simon Laws as Victims' Counsel to victims participating in the proceedings.<sup>2</sup>
3. On 1 April 2022, Mr Laws requested the approval of Ms Maria Radziejowska as Co-Counsel. Ms Radziejowska is admitted to the List of Counsel pursuant to Sections 7(3) and 18(1) of the Directive on Counsel.<sup>3</sup>
4. On 7 April 2022, the Registrar approved Ms Radziejowska as Co-Counsel in accordance with Section 18 of the Directive on Counsel and Regulations 29(2) and 36 of the Legal Aid Regulations.<sup>4</sup> In so doing, the Registrar took note of the fact that Ms Radziejowska is also assigned as Co-Counsel representing Group 1 of Victims in case KSC-BC-2020-06, and that no conflict of interest was assessed to arise from the dual appointment.
5. This submission is filed as public, whereas Annex 1 is filed confidentially pursuant to Rule 82(1)(b) and (3) of the Rules, as it contains personal information concerning Victims' Counsel and Co-Counsel.
