- 1. On 7 September 2020, the Single Judge authorised the seizure by the SPO of a first set of documents allegedly received by the KLA WVA and prohibited the copying and further dissemination of the documents and their content.¹
- 2. On 17 September 2020, the Single Judge authorised the seizure by the SPO of a second set of documents allegedly received by the KLA WVA and prohibited the recording or copying and further dissemination of the documents or their content.²
- 3. On 23 September 2020, the SPO notified the Single Judge that, pursuant to an SPO order under Articles 35(2) and 53(1) of the Law, on 22 September 2020, it had seized a third set of documents allegedly received by the KLA WVA.³
- 4. On 25 September 2020, the Single Judge found that, since the SPO Order did not foresee or result in any search of or compelled intrusion into the KLA WVA premises, and because the documents appeared to have been voluntarily provided to the SPO upon service of the SPO Order, no approval pursuant to Rule 38(3) of the Rules was required.⁴
- 5. On 24 September 2020, pursuant to the SPO's request,⁵ the Single Judge issued arrest warrants for Mr Gucati and Mr Haradinaj,⁶ together with orders for their

transfer to the detention facilities of the Specialist Chambers in The Hague, the Netherlands ("SC Detention Facilities").⁷

- 6. Also on 24 September 2020, pursuant to an SPO request,⁸ the Single Judge authorized, *inter alia*, the search of Mr Gucati and Mr Haradinaj, their location of arrest and the KLA WVA premises, as well as the seizure of any evidence believed to be connected with or relevant to the offences contained in the arrest warrants.⁹
- 7. On 25 September 2020, the Single Judge issued an order to the KLA WVA and any of its representative, member or agent to: (a) immediately notify the SPO if it has in its possession or in the future obtains any documents which appear to be confidential or non-public and relate to the work of the SITF, the SPO or the Specialist Chambers; and (b) refrain from recording, copying or disseminating such documents or their content, in the absence of authorisation of the SPO or the Single Judge.¹⁰
- 8. On 25 and 26 September 2020, Mr Gucati and Mr Haradinaj were arrested in Kosovo and transferred to the SC Detention Facilities.¹¹
- 9. On 29 September and 1 October 2020, Mr Haradinaj and Mr Gucati, respectively, appeared before the Single Judge.¹²

- 10. On 27 October 2020, the Single Judge issued three decisions on challenges and requests raised by Counsel for Mr Gucati and Counsel for Mr Haradinaj on, *inter alia*, jurisdiction, applicable law and matters related to arrest and detention.¹³
- 11. On 29 October 2020, the Single Judge issued a decision determining that the working language of the proceedings shall be English.¹⁴
- 12. On 30 October 2020, the Specialist Prosecutor submitted for confirmation before the Pre-Trial Judge a strictly confidential and *ex parte* indictment against Mr Gucati and Mr Haradinaj.¹⁵
- 13. On 9 December 2020, the Court of Appeals Panel rendered a decision denying the interlocutory appeal of Mr Gucati against the Single Judge's decision on matters related to arrest and detention.¹⁶
- 14. On 11 December 2020, the Pre-Trial Judge confirmed in part the indictment against the Accused, and ordered the SPO to submit a revised indictment, as confirmed.¹⁷
- 15. On 18 December 2020, the Accused had their initial appearances before the Pre-Trial Judge. ¹⁸ Mr Gucati pled not guilty, ¹⁹ while Mr Haradinaj declined to enter a plea. ²⁰

- 16. On 24 December 2020, the Pre-Trial Judge reviewed whether reasons for the detention of the Accused still existed and ordered their continued detention.²¹ The Accused's continued detention was thereafter reviewed and confirmed on 24 February 2021,²² 23 April 2021,²³ 23 June 2021,²⁴ 23 August 2021,²⁵ 22 October 2021,²⁶ 21 December 2021,²⁷ 21 February 2022,²⁸ and 21 April 2021.²⁹
- 17. On 8 January 2021, the Pre-Trial Judge entered a plea of not guilty on behalf of Mr Haradinaj and held the first status conference.³⁰
- 18. On 22 January 2021, the Pre-Trial Judge issued the framework decision on disclosure of evidence and related matters, setting out the principles governing and the time limits applicable for disclosure, translations of documents and evidence as well as restrictions to disclosure, including the applicable redaction regime.³¹

- 19. On 9 February 2021, the Court of Appeals Panel rendered a decision denying the interlocutory appeal of Mr Haradinaj against the Pre-Trial Judge's decision reviewing detention.³²
- 20. On 22 February 2021, the Pre-Trial Judge issued a decision on the non-disclosure of SPO official notes containing records of SPO contacts with individuals who addressed the impact of the Accused's actions on them.³³
- 21. On 23 February 2021, the Pre-Trial Judge issued a decision on the non-disclosure of documents seized from the KLA WVA on 8, 17 and 22 September 2020 and ordered certain counterbalancing measures for the non-disclosure.³⁴
- 22. On the same day, 24 February 2021, the Pre-Trial Judge held the second status conference.³⁵
- 23. On 8 March 2021, the Pre-Trial Judge issued a decision on the preliminary motions of the Defence for Mr Gucati ("Gucati Defence") and the Defence for Mr Haradinaj ("Haradinaj Defence) (collectively, the "Defence") finding, *inter alia*, that the indictment as confirmed set out with sufficient clarity and specificity the facts underpinning the charges and the crimes, including the modes of liability charged ("Decision on Preliminary Motions").³⁶

- 24. On 15 March 2021, the Defence filed their respective applications for leave to appeal the Decision on Preliminary Motions.³⁷
- 25. On 30 March 2021, the Pre-Trial Judge held the third status conference.³⁸
- 26. On 1 April 2021, the Pre-Trial Judge certified the Defence applications for leave to appeal the Decision on Preliminary Motions.³⁹
- 27. On the same day, 1 April 2021, the Pre-Trial Judge issued a decision on the non-disclosure of, inter alia, documents received by the SPO from a media outlet and ordered certain counterbalancing measures for the non-disclosure.⁴⁰
- 28. Also on 1 April 2021, the Pre-Trial Judge issued a decision on the materiality of information requested by the Defence under Rule 102(3) of the Rules and related matters.41
- 29. On 9 April 2021, the SPO submitted its Pre-Trial Brief, list of witnesses, list of proposed exhibits and Rule 109(c) disclosure chart.⁴²
- 30. On 30 April 2021, the Pre-Trial Judge held the fourth status conference.⁴³

- 31. On 26 May 2021, further to submissions from the Parties,⁴⁴ the Pre-Trial Judge issued a decision denying disclosure of certain items requested by the Defence under Rule 102(3) of the Rules ("26 May 2021 Decision").⁴⁵
- 32. On 28 May 2021, the Pre-Trial Judge held the fifth status conference.⁴⁶
- 33. On 15 June 2021, further to Defence requests for certification, the Pre-Trial Judge granted leave to appeal his 26 May 2021 Decision.⁴⁷
- 34. On the same day, 23 June 2021, the Court of Appeals Panel rendered its decision on the Defence appeal against the Decision on Preliminary Motions and, finding that the indictment lacked specificity, ordered the competent Panel to direct the SPO to file a corrected version of the indictment in light of its instructions.⁴⁸
- 35. Also on 23 June 2021, the Pre-Trial Judge ordered the SPO to file a corrected version of the indictment and informed the Parties that the transmission of the case file under Rule 98(1) of the Rules is set to take place on Friday, 16 July 2021.⁴⁹
- 36. On 5 July 2021, the SPO filed the corrected indictment ("Indictment").50

- 37. On 12 July 2021, the Defence submitted its Pre-Trial Briefs, lists of potential witnesses, lists of objections to the admissibility of evidence and lists of agreed facts.⁵¹
- 38. On 14 July 2021, the Pre-Trial Judge held the sixth and last status conference for the pre-trial stage. The Parties raised no objections against the transmission of the case file on 16 July 2021.⁵²
- 39. On 14 July 2021, the Pre-Trial Judge notified the President that the case file would be ready for transmission to a Trial Panel on Friday, 16 July 2021.⁵³
- 40. On 15 July 2021, the President assigned Trial Panel II ("Panel") to the present case upon transmission of the case file.⁵⁴
- 41. On 16 July 2021, the Pre-Trial Judge transmitted the case file to the Panel pursuant to Rule 98 of the Rules.⁵⁵
- 42. Also on 16 July 2021, the Panel unanimously elected Judge Charles L. Smith, III as its Presiding Judge.⁵⁶
- 43. On 21 July 2021, the Panel issued an order for written submissions and set the dates for the Trial Preparation Conference for 1 and 2 September 2021.⁵⁷
- 44. On 29 July 2021, the Court of Appeals Panel rendered a decision denying the interlocutory appeals of the Defence against the Pre-Trial Judge's 26 May 2021 decision ("29 July 2021 Court of Appeals Panel Decision").⁵⁸

- 45. On 1 and 2 September 2021, the Panel held the Trial Preparation Conference and set the dates for the Specialist Prosecutor's Preparation Conference.⁵⁹
- 46. On 1 September 2021, the Panel ordered the SPO to submit an updated Rule 102(3) notice listing all material in its possession that was subject to the findings of the 29 July 2021 Court of Appeals Panel Decision.⁶⁰ On the same day, the SPO requested to file an application for protective measures to be applied to the updated Rule 102(3) notice.⁶¹
- 47. On 2 September 2021, the Panel heard oral submissions from both Parties on the updated Rule 102(3) notice.⁶² On the same day, the Panel held an *ex parte* hearing only with the SPO to hear its submissions on the requested redactions.⁶³ Further to those submissions, the Panel ordered the SPO to provide, by 3 September 2021, to the Panel only: (i) an unredacted draft updated Rule 102(3) notice providing detailed notice of the relevant material, enabling a determination of materiality by the Defence; and (ii) a proposed redacted version of the same list.⁶⁴
- 48. On 3 September 2021, the SPO filed a draft, unredacted updated Rule 102(3) notice and a proposed redacted version thereof.⁶⁵
- 49. On 7 September 2021, the Panel found that the items on the draft updated Rule 102(3) notice appeared, at least *prima facie*, subject to disclosure under Rules 102 and/or 103 of the Rules. The Panel therefore ordered the SPO to file a redacted updated Rule 102(3) notice.⁶⁶

- 50. On 7 September 2021, the Panel denied the SPO's request for protective measures for two of its witnesses.⁶⁷
- 51. On 8 September 2021, the Panel held the Specialist Prosecutor's Preparation Conference and determined the date for the opening of the case.⁶⁸ The Panel also set target dates for the closing of the Specialist Prosecutor's case and the closing of the case.⁶⁹
- 52. On 9 September 2021, the SPO filed a redacted updated Rule 102(3) notice.⁷⁰
- 53. On 13 September 2021, both Defence sought disclosure from the SPO of all items listed in its updated Rule 102(3) notice, which the SPO challenged.⁷¹
- 54. On 17 September 2021, the Panel issued its order on the conduct of proceedings and determined that the working language of the proceedings shall be English ("Order on the Conduct of Proceedings").⁷²
- 55. On 22 September 2021, the Panel ordered the SPO to provide further submissions on its challenges to disclosure of the items added to the Rule 102(3) notice, including "the factual basis underpinning its assertion that Items 195-200 contain no information material to the [Entrapment Claim]".⁷³

- 56. On 27 September 2021, the Panel issued a decision denying the Defence request seeking the non-admission of certain evidence related to two SPO witnesses.⁷⁴
- 57. On 28 September 2021, pursuant to the Panel's order, the SPO submitted, to the Panel only, further submissions on some of the items listed in the updated Rule 102(3) notice.⁷⁵
- 58. On 29 September 2021, further to the SPO's request to admit items through the bar table,⁷⁶ the Panel issued a decision ("SPO Bar Table Decision"), admitting a number of items through the bar table,⁷⁷ denying the admission of certain items⁷⁸ and deferring a decision on all other items until such time as they were tendered through a witness at trial.⁷⁹
- 59. On 29 September 2021, the SPO filed, on a strictly confidential and *ex parte* basis, a transmission of an official note relating to a recent contact with a witness ("Official Note of Contact").⁸⁰
- 60. On 4 October 2021, the Panel held an *ex parte* hearing only with the SPO to hear further submissions on the Official Note of Contact.⁸¹

- 61. On 7 October 2021, further to the *ex parte* hearing, the Panel ordered the SPO to submit a further addendum to its updated Rule 102(3) notice, listing the Official Note of Contact and providing detailed notice of its content so as to enable the Defence to: (i) determine whether the document could be material to its case; and, if so, (ii) make a disclosure request to the SPO ("Order for an Addendum").⁸²
- 62. On 7 October 2021, the Presiding Judge opened the trial and the SPO read out the Indictment.⁸³ The Accused indicated that they understood the Indictment and they confirmed their plea of not guilty.⁸⁴ The Presiding Judge then informed the Accused of their rights and obligations.⁸⁵ On the same day, 7 October 2021, the SPO delivered its opening statement.⁸⁶
- 63. On 13 October 2021, pursuant to the Order for an Addendum, the SPO filed an addendum to its updated Rule 102(3) notice, adding a new item.⁸⁷
- 64. On 18 October 2021, the Panel informed the Parties that it would defer its consolidated decision on the outstanding Rule 102(3) matters until after it heard the evidence of two SPO witnesses as it could impact its decision on disclosure.⁸⁸
- 65. On 18 October 2021, the presentation of evidence for the Specialist Prosecutor began.⁸⁹ As detailed below, the Panel heard the evidence of the SPO over ten (10) hearing days.
- 66. Between 18 and 26 October 2021, the Panel heard the evidence of Zdenka Pumper (W04841). During her testimony, a number of exhibits were marked for identification

pending a decision on their admissibility and the SPO submitted "associated exhibits" presented for admission together with W04841's declarations. 90

- 67. On 21 October 2021, the Panel held a further *ex parte* hearing only with the SPO, to hear submissions on pending Rule 102(3) disclosure issues and potential counterbalancing measures.⁹¹
- 68. On 22 October 2021, the SPO filed its challenge to the disclosure of the addendum to the updated Rule 102(3) notice and made submissions on proposed counterbalancing measures.⁹² On 27 and 29 October 2021 respectively, each Defence responded.⁹³ On 1 November, the SPO replied.⁹⁴
- 69. Between 26 October and 5 November 2021, the Panel heard the evidence of three additional SPO witnesses: Halil Berisha (W04866), Miro Jukić (W04842) and Daniel Moberg (W04876).⁹⁵
- 70. On 3 November 2021, the Panel issued a consolidated decision on a number of SPO requests for non-disclosure under Rule 102(3) of the Rules ("3 November 2021 Decision"), ordering the non-disclosure of certain items and some counter-balancing measures to the non-disclosure, namely the provision to the Defence of extracts of one

item and a summary of the steps and verifications taken by the SPO in relation to six other items as well as further measures to be taken by the SPO regarding the Official Note of Contact.⁹⁶

71. On 5 November 2021, the SPO requested leave to appeal the 3 November 2021 Decision.⁹⁷ On the same day, the Panel informed the Parties that, to facilitate the expeditious conduct of the proceedings, it would hear oral submissions in response and reply from the Defence and the SPO.⁹⁸

72. On 5 November 2021, the Panel issued an oral order on the exhibits marked for identification during the testimony of W04841 and the "associated exhibits", admitting all except three exhibits.⁹⁹ Written reasons followed on 9 November 2021.¹⁰⁰

73. On 8 November 2021, the SPO indicated that it did not intend to call additional witnesses.¹⁰¹

74. On 8 November 2021, the Panel heard oral submissions from the Parties on the SPO's requests for leave to appeal the 3 November 2021 Decision. On the same day, the Panel issued a decision denying the SPO leave to appeal that decision, reiterating its order to the SPO to disclose to the Defence the material identified in the 3 November 2021 Decision.

75. On 9 November 2021, the Panel issued a scheduling order for the work plan and time limits for the next steps in the proceedings ("9 November 2021 Scheduling Order").¹⁰⁴ The Panel directed the Specialist Prosecutor formally to close his case pursuant to Rule 129 of the Rules, set time limits for filing submissions under Rule 130 of the Rules and set out a tentative schedule for the Defence Preparation Conference, the submissions under Rule 119 of the Rules and the opening of the Defence case.¹⁰⁵

76. On 10 November 2021, the Specialist Prosecutor formally closed his case. 106

77. On 15 November 2021, further to the SPO's measures and an ensuing request regarding the Official Note of Contact,¹⁰⁷ the Panel ordered the SPO to disclose to the Defence the redacted version thereof.¹⁰⁸

78. On 18 November 2021, the SPO added an item ("Item 202") to its Rule 102(3) notice and pre-emptively challenged disclosure of Item 202 to the Defence.¹⁰⁹ On 29 November 2021, both Defence responded, seeking disclosure.¹¹⁰

79. On 26 November 2021, further to the Parties' submissions,¹¹¹ the Panel issued its decision denying the Defence motions to dismiss charges.¹¹²

80. On 29 November 2021, in line with the 9 November 2021 Scheduling Order, the Gucati Defence filed its lists of witnesses and exhibits pursuant to Rule 119(2) of the Rules.¹¹³ On the same day, 29 November 2021, the Haradinaj Defence filed its list of witnesses pursuant to Rule 119(2)(a) of the Rules.¹¹⁴

81. On 30 November 2021, the Panel issued a scheduling order for the Defence Preparation Conference.¹¹⁵

82. On 2 December 2021, the Panel held the Defence Preparation Conference and determined the date for the opening of the Defence case and authorised the Haradinaj Defence to deliver its opening statement after the presentation of evidence in the Gucati case finished.¹¹⁶ The Panel also set target dates for the closing of the Defence case and for the closing of the case.¹¹⁷ The Panel ordered the Haradinaj Defence to file its exhibit list under Rule 119(2)(b) of the Rules and for both Defence to file updated exhibit lists conforming with the Order on the Conduct of Proceedings ("Order on Exhibit Lists").¹¹⁸ At the conclusion of the Defence Preparation Conference, the Panel issued an oral order on the SPO's requests to exclude in whole or in part the testimony of a number of Defence witnesses.¹¹⁹

- 83. Also on 2 December 2021, after an extension of the original time limit and in line with the Order on Exhibit Lists, the Haradinaj Defence filed a tentative list of exhibits.¹²⁰
- 84. On 3 December 2021, the Defence case was opened and the Gucati Defence delivered its opening statement.¹²¹
- 85. On the same day, 3 December 2021, the Panel issued the written reasons to its oral order on the SPO's requests to exclude in whole or in part the testimony of a number of Defence witnesses, rendered at the conclusion of the Defence Preparation Conference ("Defence Witnesses Decision"),¹²² declining to exclude the testimony of DW1246 insofar as the proposed evidence could be relevant to the Entrapment Claim.¹²³
- 86. On 6 December 2021, in line with the Order on Exhibit Lists, the Gucati Defence filed an updated exhibit list. 124
- 87. Also on 6 December 2021, the presentation of evidence for the Gucati Defence began.¹²⁵ As detailed below, the Panel heard the evidence of the Gucati Defence over five (5) hearing days.

- 88. Between 6 and 8 December 2021, the Panel heard the evidence of Mr Gucati (DW1240).¹²⁶
- 89. On 7 December 2021, the Panel denied disclosure of Item 202 to the Defence. 127
- 90. On 8 December 2021, the Panel granted the Haradinaj Defence leave to appeal certain findings of the Defence Witnesses Decision.¹²⁸
- 91. Between 9 and 10 December 2021, the Panel heard or received the evidence of six additional witnesses called by the Gucati Defence: Taibe Miftari (DW1241), Elmedina Ballhazhi (DW1242), Pren Marashi (DW1243), Metush Kryeziu (DW1244), Cele Gashi (DW1245) and Joseph Bowden (DW1248). 129
- 92. On 10 December 2021, after a further extension of the previous time limit,¹³⁰ the Haradinaj Defence filed an updated list of exhibits.¹³¹
- 93. On 10 December 2021, the Panel granted the Defence request to further cross-examine SPO witnesses W04841 and W04842 on the basis that the delayed disclosure of certain items resulted from the SPO's resistance to disclosure and that those items, for which the Panel ended up ordering disclosure, reached the Defence after the close of the SPO case and could therefore not be used by the Defence when cross-examining these witnesses.¹³²

- 94. On 15 December 2021, further to the Panel's authorisation, SPO witnesses W04841 and W04842 were recalled and further cross-examined by the Gucati Defence.¹³³
- 95. On the same day, 15 December 2021, the Haradinaj Defence delivered its opening statement.¹³⁴ After that, and further to a request by the Haradinaj Defence based on the health condition of its lead counsel, the Panel adjourned the proceedings until 11 January 2022.¹³⁵
- 96. On 17 December 2021, further to the request of the Gucati Defence to admit items through the bar table,¹³⁶ the Panel issued a decision admitting a number of items through the bar table and denying the admission of all other items.¹³⁷
- 97. On 6 January 2022, after the Panel's authorisation to add exhibits and a further extension of the previous time limit, the Haradinaj Defence filed an updated list of exhibits.¹³⁸
- 98. On 7 January 2022, the Court of Appeals Panel rendered a decision granting in part the interlocutory appeal of the Haradinaj Defence against the Defence Witnesses Decision.¹³⁹

99. On 11 January 2022, the presentation of evidence for the Haradinaj Defence began. ¹⁴⁰ As detailed below, the Panel heard the evidence of the Haradinaj Defence over seven (7) hearing days.

100. Between 11 and 14 January 2022, the Panel heard the evidence of Mr Haradinaj (DW1249).¹⁴¹

101. On 12 and 14 January 2022, the SPO added two items ("Item 203" and "Item 204") to its Rule 102(3) notice and pre-emptively stated the challenges to their disclosure to the Defence. On 20 and 21 January 2022, the Haradinaj Defence and the Gucati Defence respectively responded, seeking disclosure of Item 203 and Item 204.

102. On 14 January 2022, the Panel, overruling the SPO's objections, admitted the statement and addendum of Rashit Qalaj (DW1246) as it found that his evidence appeared to be put forth by the Defence as relevant to the Entrapment Claim. 144

103. On 14, 21, 24 and 28 January 2022, the Panel heard the evidence of three additional witnesses called by the Haradinaj Defence: Rashit Qalaj (DW1246), Anna Myers (DW1252) and Robert Reid (DW1253).¹⁴⁵

104. On 25 January 2022, the Panel granted the SPO's requests for non-disclosure of Items 203 and 204. 146

105. On the same day, 25 January 2022, the SPO added an item ("Item 205") to its Rule 102(3) notice and pre-emptively stated its challenge to its disclosure to the Defence.¹⁴⁷

106. On 27 and 28 January 2022, the Defence respectively responded, seeking disclosure of Item 205.¹⁴⁸

107. On 28 January 2022, the Panel granted the SPO's requests for non-disclosure of Item 205.¹⁴⁹

108. On 31 January 2022, the Panel held a status conference to discuss the next steps of the proceedings with the Parties.¹⁵⁰ At the status conference, the SPO indicated that it would not seek to tender any evidence in rebuttal, which rendered the question as to whether the Defence intend to call evidence in rejoinder moot.¹⁵¹

109. On 1 February 2022, further to a request from the Defence to that effect,¹⁵² the Panel denied the Defence application for leave to appeal, or reconsideration of, its decision granting non-disclosure of Item 205.¹⁵³

110. On 1 February 2022, the Panel directed the Defence to close their case pursuant to Rule 131 of the Rules.¹⁵⁴

- 111. On 2 February 2022, pursuant to the Panel's order, both Defence teams formally closed their cases.¹⁵⁵
- 112. On 3 February 2022, the Panel issued three decisions. First, the Panel took note of the facts agreed upon between the Parties. ¹⁵⁶ Second, the Panel admitted two items into evidence pursuant to Rule 132 of the Rules. ¹⁵⁷ Third, the Panel closed the evidentiary proceedings in the case ("3 February 2022 Decision"). ¹⁵⁸
- 113. On 3 March 2022, pursuant to the 3 February 2022 Decision, the Parties submitted their Final Trial Briefs (respectively "SPO Final Trial Brief"; "Gucati Final Trial Brief"; "Haradinaj Final Trial Brief"). 159
- 114. On 10 March 2022, further to a request from the SPO,¹⁶⁰ the Panel ordered the Defence to disclose any additional evidence it wishes to adduce in relation to sentencing by 14 March 2022.¹⁶¹
- 115. On 14 and 15 March 2022, the Gucati Defence and the Haradinaj Defence respectively disclosed eleven and six statements for the purposes of sentencing. ¹⁶² On 16 March 2022, the Panel admitted one of the statements in part and the remainder of the statements in full. ¹⁶³

116. From 14 to 17 March 2022, pursuant to the Panel's order¹⁶⁴ and in accordance with Rule 135 of the Rules, the Panel heard the Parties' Closing Statements.¹⁶⁵ The Panel further heard the Parties' submissions on sentencing, in the event of a finding of guilt,¹⁶⁶ and the statement of each of the Accused.¹⁶⁷ The Panel also stated that it would determine an appropriate sentence with the pronouncement of the trial judgment should any conviction be entered.¹⁶⁸

117. On 17 March 2022, the Panel closed the case. 169

118. On 6 April 2022, the Court of Appeals Panel denied, in a consolidated decision, both interlocutory appeals of the Haradinaj Defence against the Panel's detention review decisions.¹⁷⁰

119. On 9 May 2022, upon request of the Gucati Defence,¹⁷¹ the Panel granted Mr Gucati a three-day custodial visit on compelling humanitarian grounds.¹⁷²

120. On 17 May 2022, the Panel rejected the request of the Defence for permission to make further submissions on disclosure.¹⁷³
