THE PRESIDENT of the Specialist Chambers ("President"), noting Articles 33(1)(c) and 46 of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, Rules 172 and 173(1) of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns a Court of Appeals Panel to decide on the "Haradinaj Defence Notice of Appeal of Trial Judgement" and the "Public Redacted Version of Gucati Notice of Appeal re Trial Judgment KSC-BC-2020-07/F00611 [...]" (collectively "Notices of Appeal").

#### I. PROCEDURAL BACKGROUND

1. On 18 May 2022, Trial Panel II rendered the "Trial Judgment", wherein it, *inter alia*, convicted Messrs Hysni Gucati and Nasim Haradinaj of obstructing official persons in performing official duties by serious threat and participation in the common action of a group, intimidation during criminal proceedings and violating the secrecy of proceedings through unauthorised revelation of secret information, identities and personal data of protected witnesses.<sup>2</sup> The Trial Panel sentenced Messrs Gucati and Haradinaj to four and a half years of imprisonment and a fine of 100 euros.<sup>3</sup>

2. On 20 June 2020, Messrs Gucati and Hardinaj filed their Notices of Appeal.
