**THE PRE-TRIAL JUDGE**,<sup>1</sup> pursuant to Articles 21(6) and 39(13) of the Law No. 05/L-53 on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rules 95(5), 96(1) and (2), and 102(3) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), hereby renders this order.

## I. PROCEDURAL BACKGROUND

1. On 26 October 2020, the Pre-Trial Judge confirmed the indictment against Hashim Thaçi ("Mr Thaçi"), Kadri Veseli ("Mr Veseli"), Rexhep Selimi ("Mr Selimi"), and Jakup Krasniqi ("Mr Krasniqi") (collectively referred to as the "Defence").<sup>2</sup>
2. On 12 March 2021, the Pre-Trial Judge issued the "Decision on Categorisation of Evidence Under Rule 109(c) and Related Matters", in which case-specific categorisation of Rule 102(1)(b) material was ordered and the deadline for disclosure of such material was extended to 23 July 2021.<sup>3</sup>
3. On 24 June 2021, pursuant to a request of the Specialist Prosecutor's Office ("SPO"),<sup>4</sup> the Pre-Trial Judge extended the deadlines in relation to Rule 102(3) material.<sup>5</sup>

4. On 21 July 2021, the Pre-Trial Judge extended the deadline for the provision of Rule 102(1)(b) material to 27 September 2021.<sup>6</sup>
5. On 8 September 2021, the Pre-Trial Judge issued a decision amending the procedure in relation to disclosure of Rule 102(3) material.<sup>7</sup>
6. On 24, 28, and 30 September 2021, the Pre-Trial Judge granted various requests for extension of time in relation to the disclosure of Rule 102(3) material.<sup>8</sup>
7. On 18 October 2021, following a request of the SPO,<sup>9</sup> the Pre-Trial Judge suspended the SPO deadlines in relation to Rule 102(3) material and ordered the Defence and Victims' Counsel to make observations on the SPO request, if they so wished, in their submissions for the upcoming status conference.<sup>10</sup>
8. On 29 October 2021, at the eighth status conference: (i) the deadline for the disclosure of outstanding Rule 102(1)(b) material and the translation of such material was extended to 31 January 2022;<sup>11</sup> (ii) the remaining Defence deadlines for Rule 102(3) material were suspended;<sup>12</sup> (iii) the deadline for the SPO's pre-trial brief and related material was set to 17 December 2021;<sup>13</sup> and (iv) the SPO was ordered to provide its Rule 109(c) chart by 28 January 2022.<sup>14</sup>

9. On 17 December 2021, the SPO filed its pre-trial brief and related material, including a list of witnesses (“Witness List”) and a list of exhibits (“Exhibit List”).<sup>15</sup>
10. On 28 January 2022, the SPO submitted the Rule 109(c) Chart.<sup>16</sup>
11. On 31 January 2022, the SPO filed its notice of Rule 102(1)(b) material indicating that it has disclosed all previously identified Rule 102(1)(b) material.<sup>17</sup>
12. On 22 April 2022, the Pre-Trial Judge confirmed the amendments to the indictment.<sup>18</sup>
13. On 29 April 2022, the SPO filed an amended indictment and related documents.<sup>19</sup>
14. On 10 May 2022, separate further appearances were held for Mr Thaçi, Mr Veseli, Mr Selimi and Mr Krasniqi.<sup>20</sup>

15. On 20 May 2022, pursuant to a scheduling order of the Pre-Trial Judge,<sup>21</sup> a twelfth status conference was held (“Twelfth Status Conference”).<sup>22</sup> At the Twelfth Status Conference: (i) the deadline for the SPO to complete its review of material obtained after January 2022 and to file protective measures requests or disclose material falling under Rule 103 of the Rules was set to 30 June 2022;<sup>23</sup> (ii) the deadline for the SPO to finalise its processing of Defence requests for the disclosure of Rule 102(3) material, to request protective measures or submit materiality challenges, and to disclose all material not subject to protective measures requests or materiality challenges was set to 30 September 2022;<sup>24</sup> and (iii) the deadline for the Defence’s pre-trial brief was set to 21 October 2022.<sup>25</sup>

16. On 30 June 2022, the SPO provided notification of its completion of its review, pursuant to Rule 103 of the Rules, of materials registered between 31 January 2022 and 16 June 2022.<sup>26</sup>

## II. APPLICABLE LAW

17. Pursuant to Rule 96(1) of the Rules, following the first status conference, the Pre-Trial Judge shall convene subsequent status conferences as deemed necessary in order to: (i) organise exchanges between the Parties and, where applicable, Victims' Counsel so as to ensure expeditious preparation for trial; (ii) take steps to ensure that all necessary preparations are being conducted by the Parties in a timely and diligent fashion; and (iii) review the status of the case and allow the Parties and, where applicable, Victims' Counsel the opportunity to raise issues in relation thereto.

18. Pursuant to Article 21(6) of the Law, all material and relevant evidence or facts in possession of the SPO which are for or against the Accused shall be made available to the Accused before the beginning of and during the proceedings, subject only to restrictions which are strictly necessary and when any necessary counter-balance protections are applied. Pursuant to Rule 102(3) of the Rules, the SPO shall provide detailed notice to the Defence of any material and evidence in its possession.

19. Pursuant to Rule 95(5) of the Rules, after submission of the items under Rule 95(4) of the Rules, the Pre-Trial Judge shall invite the Defence to file a pre-trial brief within a set time limit. Moreover, within a time limit set by the Pre-Trial Judge, the Defence shall notify the SPO of its intention to offer a defence of alibi or any other grounds excluding criminal responsibility, including that of diminished or lack of mental capacity, intoxication, necessity, duress, and mistake of fact or law.

20. Pursuant to Rule 96(2) of the Rules, with the Accused's written consent after receiving advice from Counsel, a status conference may be conducted: (i) in the Accused's presence, with Counsel participating via video-conference; (ii) in Defence Counsel's presence, with the Accused participating via video-conference; or (iii) in the Accused's absence, with Counsel present or participating via video-conference. In addition, any request to attend the status conference via video-conference, shall be made directly to the Registrar, in accordance with the Registrar's Practice Direction on Video Links (KSC-BD-23/COR), sufficiently in advance for the Registrar to take the appropriate steps, including to inform the Pre-Trial Judge.<sup>27</sup>

### III. DISCUSSION

21. Having considered the scheduling preferences expressed by the Parties and Victims' Counsel as well as courtroom availability, the Pre-Trial Judge convenes the Thirteenth Status Conference in this case on Wednesday, 13 July 2022, at 13:30.

22. During the hearing, the Pre-Trial Judge will ask the Parties for updates, if any, on the outstanding issues from the Twelfth Status Conference, and the written and oral submissions they have made thereon. Specifically, and in addition, the Pre-Trial Judge will seek updates on the following issues, in the sequence set out below:

(1) Disclosure:

- a. Whether the SPO can provide an update on its progress towards the completion of the procedure for the disclosure of Rule 102(3) material, in particular: (i) the progress made with respect to existing Defence requests for Rule 102(3) material, including the amount of material that remains to be disclosed with respect to each request; (ii) whether the SPO foresees making

any materiality challenges in the near future; (iii) whether the SPO foresees any difficulty in meeting its deadline of 30 September 2022 for the SPO's review, including any materiality challenges and/or protective measures requests, in relation to currently pending Defence requests for the disclosure of this material; and

- b. Whether progress has been made in the disclosure process with respect to Rule 107 material, and whether any additional applications pursuant to this rule are imminent.

(2) Defence investigations and next steps:

- a. Whether the Defence can provide more information on the status of their investigations, in particular what steps they have taken to move their investigations forward;
- b. Similarly, whether the Defence can provide updates on any intention to make requests concerning unique investigative opportunities, pursuant to Rule 99(1) of the Rules, and whether such requests can be made by 1 September 2022;
- c. Whether the Defence can provide more information on any intention to give notice of an alibi or grounds for excluding responsibility, pursuant to Rule 95(5) of the Rules, and any associated disclosure, pursuant to Rule 104(1) and (2) of the Rules, and whether such notices, if any, can be filed by 1 September 2022;
- d. Whether there has been any progress with respect to discussions on points of agreement on law and/or facts, pursuant to Rules 95(3) and 156 of the Rules, and whether such points of agreement can be provided by 1 September 2022;



- e. Whether and when the Parties can identify objections to the admissibility of evidentiary material disclosed, pursuant to Rule 95(2)(e) of the Rules, and whether such objections can be filed by 8 September 2022;
- f. Whether and when the Parties expect to be able to identify a list of issues subject to dispute and one with issues not subject to dispute pursuant to Rule 95(5)(b) of the Rules, and whether such lists can be provided by 8 September 2022; and
- g. Whether the Defence foresees any difficulty in the filing of their respective pre-trial briefs by 21 October 2022.

(3) Proposals for streamlining the case:

- a. Whether and to what extent is the SPO's Witness List up-to-date in terms of the number of witnesses the SPO intends to call, their intended mode of testimony, and the estimated time for such witnesses to testify and whether the SPO can provide an updated Witness List by 1 September 2022;
- b. Whether the SPO is amenable to providing the Defence with a list of witnesses it intends to call (in the order it intends to call them) for the first three months of trial;
- c. Whether the SPO is amenable to streamlining their case by dropping some crime sites, limiting the number of witnesses per crime site, limiting the number of *viva voce* witnesses, limiting the total number of witnesses and/or limiting the number of items on the Exhibit List;
- d. Whether and to what extent time limits can be set for all Parties to question each witness and whether the Defence can designate one representative for cross examining certain witnesses;

- e. Whether the Parties are able to indicate how many hours per day and weeks per month they would be ready to sit on average; and
- f. Whether and to what extent the Parties support the setting of global time-limits for each Party's case, including whether, in light of the foregoing considerations, the presentation of the SPO's case could be limited to one calendar year and the presentation of each respective Defence case could be limited to three months.

23. Finally, taking into consideration courtroom availability, the Parties and participants are invited to indicate their availability on Thursday, 8 September 2022, for the next status conference in this case.

24. The Parties and participants are invited to file written submissions, if they so wish, on any of the above matters. Should the Parties or participants wish to raise any additional matter not listed in this order during the upcoming status conference, including difficulties with Legal Workflow or translations, they are invited to include these matters in their written submissions. The Parties and participants are invited to file any such submissions by noon on Friday, 8 July 2022.

## IV. DISPOSITION

25. For the above-mentioned reasons, the Pre-Trial Judge hereby:

- a. **DECIDES** to convene a status conference in the presence of the SPO, Victims' Counsel and the Defence, at **13:30 on Wednesday, 13 July 2022;**  
and
- b. **REQUESTS** the Parties and participants to provide written submissions, if they so wish, by noon on **Friday, 8 July 2022**, as set forth in paragraph 24, above.
