I. INTRODUCTION

- 1. On 20 June 2022, the Notice of Appeal on behalf of Mr Gucati was distributed ("Gucati Notice of Appeal")¹.
- 2. On the same date, the Notice of Appeal on behalf of Mr Haradinaj was distributed² ("Haradinaj Notice of Appeal").
- 3. Ground 18 of the Gucati Notice of Appeal sought to incorporate Grounds 7, 23, 24 and 25 of the Haradinaj Notice of Appeal.
- 4. On 27th June 2022, the Prosecution filed the Prosecution Request for Order to Haradinaj Defence to refile its Notice of Appeal and Related Matters ("Prosecution Request")³.
- 5. On 1 July 2022, a Panel of the Court of Appeals Chamber handed down its decision on the Prosecution Request ("Decision")⁴. In doing so, the Panel 'struck' Ground 18 of the Gucati Notice of Appeal *proprio motu* and ordered the Appellant should he wish to maintain the content of his Ground 18, to re-file a notice of appeal without 'incorporating submissions made elsewhere'.

6. The Appellant hereby applies for an extension of 151 words to the word limit for the re-filed notice of appeal, to permit him to insert the content of Grounds 7, 23, 24 and 25 of the Haradinaj Notice of Appeal into the Appellant's re-filed notice of appeal.

II. SUBMISSIONS

- 7. In the Decision, the Panel acknowledged that the Gucati Notice of Appeal "respects" the 2,800 word maximum⁵, with the Gucati Notice of Appeal containing exactly 2,800 words.
- 8. No criticism was made in the Prosecution Request of the Gucati Notice of Appeal.
- 9. No criticism was made in the Prosecution Request of Grounds 7, 23, 24 and 25 of the Haradinaj Notice of Appeal.
- 10. The extension of the word count sought has been calculated on the bare minimum number of additional words required to replace Ground 18 of the Gucati Notice of Appeal with the content of Grounds 7, 23, 24 and 25 of the Haradinaj Notice of Appeal.
- 11. The extension of the word count sought is very modest (151 words) and will add less than 2 minutes reading time to the re-filed notice of appeal.
- 12. Without an extension of the word limit, the Appellant cannot comply with the direction to re-file the notice of appeal so as to maintain the content of Ground

18 in compliance with the instructions to remove grounds incorporating submissions made elsewhere.

- 13. The word limit should not be used as an arbitrary guillotine so as to prevent otherwise permissible and properly drafted grounds of appeal (as Grounds 7, 23, 24 and 25 of the Haradinaj Notice of Appeal, in isolation, are) from being argued by the Appellant.
- III. CLASSIFICATION
