1. Pursuant to Rule 26(1) of the Rules,¹ the Registrar hereby informs the Pre-Trial Judge of the approval of Ms Rudina Jasini ('Ms Jasini') as Co-Counsel for Mr Rexhep Selimi ('Mr Selimi').
2. On 14 February 2022, Counsel for Mr Selimi, Mr David Young, informed the Head of the Defence Office that he would like to be assisted by Ms Jasini as Co-Counsel. Counsel had already provided relevant documentation pursuant to Section 18 of the Directive on Counsel in relation to Ms Jasini's approval by the Registrar as Consultant.²
