- 1. Pursuant to Article 36(1) and 41 of the Practice Direction on Files and Filings before the Kosovo Specialist Chambers, Counsel for Kadri Veseli, Counsel for Hashim Thaçi, Counsel for Rexhep Selimi, and Counsel for Jakup Krasniqi (together, "Defence") jointly requests a variation of the word limit for submitting a Joint Reply to the Prosecution response to 'Joint Defence Motion for Disclosure Pursuant to Rule 103'.1
