1. As ordered by the Pre-Trial Judge,¹ the Specialist Prosecutor's Office ('SPO') hereby submits its latest notice under Rule 102(3) of the Rules² ('October 2022 Notice').³
2. The October 2022 Notice includes all items falling under Rule 102(3) which have been identified or cleared⁴ since the July 2021 Notice,⁵ up until the beginning of September 2022. As previously submitted, the SPO will continue to discharge its obligations under Rule 102(3), including as additional items falling within the scope of the rule are obtained or cleared.⁶
