I. INTRODUCTION

- 1. Pursuant to Rule 95(5) of the Rules of Procedures and Evidence, Article 36(1) and 44 of the Practice Direction on Files and Filings before the Kosovo Specialist Chambers, the Defence for Messrs Kadri Veseli, Hashim Thaçi and Jakup Krasniqi (together, "Defence") requests a variation of the word limit for submitting its pre-trial brief, following the Pre-Trial Judge's order at the 12th Status conference.¹
- 2. More specifically, the Defence requests that it be entitled to submit a pre-trial brief which shall not exceed <u>25,000 words</u>, *i.e.* an extension of 5,000 words.

II. SUBMISSIONS

A. Good Cause

3. At the 12th Status conference, the Pre-Trial Judge requested the Defence teams to file their respective pre-trial brief, if any, by 21 October 2022.² Good cause exists to warrant a variation of the word limit, considering (i) the length of the SPO's pre-trial brief;³ (ii) the numerous allegations which the Defence must acknowledge and respond to;⁴ and (iii) the substantive legal elements which must be considered.⁵

B. Timing of the Request

4. The Defence is requesting a limited extension of the word limit, 11 days prior to the deadline. Considering that the SPO filed a more significant request, within a similar timeframe, the Defence considers this request to be timely.⁶

C. Lack of Prejudice

5. No prejudice is envisioned from granting the request, as the SPO was granted an additional 100,000 words and the Defence is requesting 5000 words.⁷

III. CONCLUSION

6. In light of the aforementioned, the Defence respectfully requests the Pre-Trial Judge to order the word limit variation sought in paragraph 2.
