I. INTRODUCTION

- Pursuant to Rule 9(5)(a) of the Rules of Procedure and Evidence, and Article 36(1) and 41 of the Practice Direction on Files and Filings before the Kosovo Specialist Chambers, the Defence for Mr Kadri Veseli, ("Defence") requests a variation of the word limit to its consolidated response to SPO filings F00995, F00996 and F01003.¹
- 2. More specifically, the Defence requests that it be entitled to submit a consolidated response which shall not exceed <u>9,000 words</u>, *i.e.* an extension of 3,000 words.
- II. SUBMISSIONS
- 3. On 5 October 2022, the SPO filed 3 requests for protective measures to 102(3) material requested by the Defence. The Defence intends to submit one consolidated response to these three requests. A consolidated response will provide more cogent submissions by addressing overlapping issues in a single filing. Nonetheless, the SPO's requests total over 70 annexes, for which the Defence needs sufficient words to respond meaningfully.² For these reasons, the Defence submits that the request is supported by good cause.
- The request is timely, given the response deadline on the 17 October 2022.
 Furthermore, no prejudice is envisioned from granting the request.
