I. INTRODUCTION

- 1. On 8 September 2022 the Pre-Trial Judge ordered the Defence to file notices of alibi or grounds for excluding responsibility to the extent possible pursuant to Rule 95(5) of the Rules of Procedure and Evidence.¹
- 2. In accordance with the Alibi Notice Order and pursuant to Rule 95(5)² the Defence for Mr. Selimi ("Defence") hereby files notice regarding its intent to offer a defence of alibi or any other grounds excluding criminal responsibility ("Alibi Notice").

II. SUBMISSIONS

- 3. The Defence has previously notified the SPO that it "envisage[s] potentially needing to give notice of an alibi or grounds for excluding responsibility, pursuant to Rule 95(5) of the Rules, subject to the redacted allegations in the Indictment being unredacted".³ At the present time, based on the redacted versions of the Indictment and SPO Pre-Trial Brief, and in light of the evidence and information disclosed to the Defence thus far, Mr. Selimi does not intend to offer a defence of alibi or any other grounds excluding criminal responsibility.
- 4. As noted in past submissions,⁴ and in the recently filed Selimi Defence Pre-Trial Brief;⁵ the extensive and compounded redactions to the Amended Indictment,

SPO Pre-Trial Brief and the underlying evidence have resulted in a situation whereby the particulars of the SPO's case, and in some instances entire allegations,⁶ are unknown to the Defence and will remain so until at least 30 days before trial,⁷ or 30 days before the witness in question will testify.

5. As such, while the Defence does not intend to offer a defence of alibi at the present time, it reserves its right to notify the SPO of its intent to offer such a defence once the relevant redactions are lifted and it has been properly notified of the SPO's case.
