THE PRE-TRIAL JUDGE,¹ pursuant to Rule 98(1) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers ("Rules"), hereby issues this decision.

I. PROCEDURAL BACKGROUND

- 1. On 30 October 2020, further to a decision by the Pre-Trial Judge ("Confirmation Decision"),² the Specialist Prosecutor's Office ("SPO") submitted a confirmed indictment against Hashim Thaçi, Kadri Veseli, Rexhep Selimi, and Jakup Krasniqi (collectively the "Accused").³
- 2. On 4 and 5 November 2020, the Accused were arrested, pursuant to arrest warrants issued by the Pre-Trial Judge.⁴ On the same days, the Accused were

transferred to the Detention Facilities of the Specialist Chambers in The Hague, the Netherlands.⁵

- 3. On 4 November 2022, the Pre-Trial Judge informed the Parties and Victims' Counsel that the transmission of the case file to the Trial Panel is anticipated to take place before the end of the year.⁶
- 4. On 30 November 2022, the Pre-Trial Judge notified the President of the Specialist Chambers ("President") that a complete case file would be ready for transmission on Thursday, 15 December 2022.⁷
- 5. On 30 November 2022, the President assigned the case to Trial Panel II, composed of Judges Charles Smith III, Christoph Barthe, Guénaël Mettraux and Fergal Gaynor (reserve).8

II. APPLICABLE LAW

- 6. Pursuant to Rule 98(1) of the Rules, after receiving the SPO and the Defence respective Pre-Trial Briefs, lists of witnesses and lists of exhibits, as stipulated in Rule 95(4) and (5) of the Rules, the Pre-Trial Judge shall transmit to the Trial Panel a complete case file consisting of:
 - (a) The indictment as confirmed;
 - (b) All filings and material submitted through the electronic court management system;
 - (c) Any evidentiary material received not subject to paragraph (1)(b);
 - (d) Any other correspondence with respect to the case not filed with the Court Management Unit;
 - (e) A Handover Document summarising:
 - (i). the arguments of the Parties and, where applicable, Victims' Counsel on the facts and the applicable law;
 - (ii). the points of agreement;
 - (iii). a list of the orders and decisions rendered by the Pre-Trial Judge;
 - (iv). the evidentiary material produced by each Party;
 - (v). suggestions as to the number and relevance of the witnesses to be called;
 - (vi). the questions of fact and law that are in dispute;
 - (vii). the state of advancement of the disclosure process;
 - (viii). all meetings with the Parties; and
 - (ix). any other matter that remained unresolved;

- (f) Any application and decision concerning disclosure; and
- (g) Any other material relevant to the case.
- 7. Pursuant to Rule 98(2) of the Rules, the transmission of the case file shall be completed by means of electronic access.

III. DISCUSSION

- 8. The Pre-Trial Judge finds that all necessary procedural steps have been taken in order to consider case file KSC-BC-2020-06 complete and, therefore, ready to be transmitted to Trial Panel II, in accordance with Rule 98 of the Rules.
- 9. In particular, the Pre-Trial Judge has prepared a Handover Document (Annex 1), with accompanying Annexes 2 to 4, containing the information prescribed by Rule 98(1)(e) of the Rules, for the benefit of the Trial Panel, the Parties and Victims' Counsel. The Pre-Trial Judge specifies that, due to the non-public information contained in the Handover Document, it cannot be made public at this stage. The Handover Document is annexed to this decision.

IV. DISPOSITION

10. For the above-mentioned reasons, the Pre-Trial Judge hereby **TRANSMITS** case file KSC-BC-2020-06 to Trial Panel II, including the Handover Document annexed to the present decision.
