Decision on Gucati Application for Reclassification or Public Redacted Versions of Court of Appeals Panel Decisions

Counsel for Nasim Haradinaj: Toby Cadman THE PANEL OF THE COURT OF APPEALS CHAMBER of the Kosovo Specialist Chambers ("Court of Appeals Panel", "Appeals Panel" or "Panel" and "Specialist Chambers", respectively),¹ acting pursuant to Article 33(1)(c) of the Law on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rule 172 of the Rules of Procedure and Evidence ("Rules"), is seised of an application filed by Mr Hysni Gucati ("Application" and "Gucati", respectively) seeking the reclassification, or issuance of public redacted versions, of five confidential Appeals Panel decisions (collectively, the "Five Decisions").² The Specialist Prosecutor's Office ("SPO") did not respond.

1. Gucati submits that the Five Decisions should be reclassified as public, or that public redacted versions of these decisions should be issued.³ He also states that the Appeals Panel has ordered the Defence to file public redacted versions of some filings, but not others.⁴

2. The Appeals Panel recalls that all submissions filed before the Specialist Chambers shall be public unless there are exceptional reasons for keeping them confidential, and that Parties shall file public redacted versions of all non-public submissions filed before the Panel.⁵ Moreover, the Panel recalls that the obligation for

filings to be public as far as possible necessarily implies that filings must be made public (for example, through redaction) as soon as possible.⁶ Not only does this uphold the principle of publicity of proceedings, but also has practical advantages, such as aiding the Panel in assessing which pieces of information within, for example, a confidential filing should be redacted from its decision and which could be made public.⁷ Therefore, while the Panel has in many cases explicitly ordered parties to file public redacted versions of their submissions where the Parties had not yet done so, as Gucati notes, it has also reminded parties to file public redacted versions of their filings as soon as possible, rather than waiting for an order from the Panel before doing so.⁸

3. In this regard, the Panel notes that neither the Defence nor the SPO have filed public redacted versions of any of the submissions underlying the Five Decisions, nor sought their reclassification as public.⁹ While none of the Five Decisions explicitly

ordered the Parties to file public redacted versions of their submissions, as Gucati alludes to, the Parties were able to do so at any time. This would assist the Appeals Panel in preparing public redacted versions of the Five Decisions.

4. The Appeals Panel consequently orders the Parties to file public redacted versions of their submissions underlying the Five Decisions, as enumerated in footnote 9, or make submissions on why public redacted versions of certain filings cannot (yet) be filed, within seven days of being notified of this Decision. Thereafter, the Appeals Panel will issue in due course, to the extent possible, public redacted versions of the Five Decisions.

5. Finally, the Panel orders the Parties to file public redacted versions of two additional filings,¹⁰ or make submissions on why public redacted versions of either of these filings cannot (yet) be filed, within seven days of being notified of this Decision. Thereafter, the Appeals Panel will issue in due course, to the extent possible, public redacted versions of the decisions resulting from these filings.¹¹

I. DISPOSITION
