

Pursuant to the Decision¹ and Rule 82 of the Rules,² the Specialist Prosecutor's Office ('SPO') hereby requests reclassification of Annex 11³ to the Request⁴ and filing F00920⁵ as public, as the reasons for their respective classifications no longer exist.
