# Decision on the date for the commencement of the trial, evidence presentation and related matters

**Victims' Counsel** Simon Laws **TRIAL PANEL I** (Panel) hereby renders this decision on the date for the commencement of the trial, evidence presentation and related matters.

# I. PROCEDURAL BACKGROUND

1. On 21 September 2022, the Pre-Trial Judge transmitted the case file to the Panel.<sup>1</sup>

2. On 10 October 2022, further to an order from the Panel,<sup>2</sup> the Specialist Prosecutor's Office (SPO),<sup>3</sup> the Defence for Pjetër Shala (Defence and Accused)<sup>4</sup> and Victims' Counsel<sup>5</sup> made submissions regarding, among others, the commencement of the trial and the opening statements.

3. On 18, 19 and 20 October 2022, the Panel held trial preparation conferences, where the Parties and Victims' Counsel made further submissions.<sup>6</sup>

4. On 28 October 2022, the SPO filed an amended list of witnesses.<sup>7</sup>

# II. APPLICABLE LAW

5. The Panel notes Article 40(2) and (6) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office and Rules 9(5)(a), 116(1), 117(2), 118(3), 124, 125 and 126 of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers (Rules).

# III. ANALYSIS

# A. COMMENCEMENT OF TRIAL AND OPENING STATEMENTS

6. Having received all necessary submissions from the Parties and Victims' Counsel, the Panel does not find it necessary to hold any further preparation conferences before the opening of the trial. The Panel notes that the Parties and Victims' Counsel also do not request any further preparation conferences.<sup>8</sup> Further, the SPO, the Defence and Victims' Counsel are, at this date, ready to start the trial. Both the SPO and Victims' Counsel have indicated that they are prepared to start whenever the date is set.<sup>9</sup> The Defence indicated that it expected to be trial ready in January 2023.<sup>10</sup> Accordingly, the Panel varies, pursuant to Rule 9(5)(a) of the Rules, the time limit prescribed in Rule 118(3) of the Rules and sets **Tuesday, 21 February 2023, 09:30 hours**, as the date and time for the opening of the trial.

7. The trial shall open with the procedures set out in Rules 124 and 125 of the Rules. Pursuant to Rule 124(1) of the Rules, the Presiding Judge shall open the trial and ask the Registrar to call the case. Thereafter, the trial shall proceed with the

reading by the SPO of the Corrected Confirmed Indictment,<sup>11</sup> pursuant to Rule 124(2) of the Rules. In order to ensure the efficiency of the proceedings and seeing that the Defence does not object,<sup>12</sup> the Panel does not find it necessary for the SPO to read out to the Accused the Corrected Confirmed Indictment in its entirety, but considers it sufficient to read the charges as read out to him during the initial appearance.<sup>13</sup> The Accused will be subsequently asked whether he understands the Corrected Confirmed Indictment and will be given the opportunity to confirm his initial plea pursuant to Rule 124(3) of the Rules.<sup>14</sup> Pursuant to Rule 125 of the Rules, the Presiding Judge will then inform the Accused of his rights and obligations and the measures provided for under Rule 61(2) of the Rules.

8. The Panel further notes that the SPO, the Defence and Victims' Counsel have all indicated that they intend to make opening statements following the opening of the trial.<sup>15</sup> The Panel accordingly decides to hear the opening statements of the SPO, Victims' Counsel and the Defence, in this order, on **Tuesday**, **21 February 2023**, **at 09:30** (SPO and Victims' Counsel) and **Wednesday**, **22 February 2023**, **at 09:30** (Defence).

9. With regard to the length of the opening statements, the Panel decides to allocate to the SPO, the Defence and Victims' Counsel two (2) hours each for their opening statements, as requested.<sup>16</sup>

10. The Parties and Victims' Counsel are authorised to use visual aids and other materials during their respective opening statements, which shall be communicated to the Panel, the Parties and Victims' Counsel, as the case may be, *via* e-mail, *via* the

Court Management Unit. This shall be done at the earliest opportunity and no later than **Monday**, **13 February 2023**. Any objections to the use of any of the visual aids or other material shall be raised also *via* e-mail no later than **Wednesday**, **15 February 2023** and any responses to objections no later than **Friday**, **17 February 2023**. The Parties and Victims' Counsel shall indicate whether the visual aids and materials they intend to use may be broadcasted to the public.

11. Mindful of the principle of publicity of the proceedings, the Panel directs the Parties and Victims' Counsel to present their opening statements to the greatest extent possible in open session and to rely on visual aids and materials that can be broadcasted to the public. Where this is not possible, the Parties and Victims' Counsel are directed to group arguments to be made in private and/or closed session together, to enhance the efficiency of the proceedings and avoid unnecessarily moving between open and private or closed sessions. The above directions are without prejudice to the protective measures in place for victims and witnesses and the Parties and Victims' Counsel's right to present their arguments in full.

12. As the Defence has chosen to give an opening statement directly after the opening statements of the SPO and Victims' Counsel, it may not make any further opening statement after the closing of the SPO's case and before the opening of its own case.<sup>17</sup> This does not prevent the Defence from making submissions in accordance with the Rules.

13. Noting that the Accused expressed his wish to make an unsworn statement, pursuant to Rule 142(1) of the Rules,<sup>18</sup> the Panel directs the Defence to confirm, by **Friday, 10 February 2023**, whether this will take place directly before or after the Defence opening statement and, if so, how much time the Accused will require.

Should the Accused finally choose to make an unsworn statement, the Panel directs the Defence to advise the Accused that statements of a political nature, statements which are offensive to witnesses, victims, the SPO, the Panel, or the Specialist Chambers as an institution, statements which have no relevance to the case, or which reveal confidential information of any kind will not be tolerated.

# B. REQUESTS PURSUANT TO RULE 117(2) OF THE RULES

14. According to Rule 117(2) of the Rules, the Panel shall set a time limit for any motions to be made prior to the opening of the case. Such motions may be made by the SPO, the Defence, as well as Victims' Counsel. Such motions should include any matter the resolution of which is, in the view of the Parties or Victims' Counsel, as the case may be, a pre-condition for the start of the trial. Accordingly, the Panel considers it appropriate to set **Wednesday**, **8 February 2023**, as the deadline for the Parties and Victims' Counsel to file any motions within the meaning of Rule 117(2) of the Rules. Any responses to such motions shall be filed by **Tuesday**, **14 February 2023** and any replies by **Thursday**, **16 February 2023**. The Panel may rule orally on any such motions before the opening statements.

# C. PRESENTATION OF EVIDENCE

15. Considering that the sole available courtroom is to be shared with the other Panel(s) of the Specialist Chambers, the Panel decides that the evidence presentation shall commence on **Monday**, **27 March 2023**, **at 09:30**.<sup>19</sup> The Panel will sit for the first

evidentiary block until **Friday, 31 March 2023**. The following evidentiary blocks (until the judicial summer recess) are:

- Monday, 1 May 2023, at 09:30 to Friday, 5 May 2023;
- Tuesday, 30 May 2023, at 09:30 to Friday, 9 June 2023; and
- Monday, 26 June 2023, at 9:30 to Wednesday, 28 June 2023 and Friday, 30 June 2023, at 09:30 to Friday, 7 July 2023.

These dates are subject to change, depending on the availability of the courtroom. Future hearing dates will be communicated in due course.

16. The Panel has taken note of the SPO's list of witnesses, including their tentative order of appearance, the mode of testimony and the estimated time for direct examination.<sup>20</sup> The Panel directs the SPO to confirm by **Thursday**, **2 February 2023**, whether the order of appearance of the first three witnesses, as set out in the SPO's list of witnesses, remains the same.

17. The Panel informs the Parties and Victims' Counsel that further details on the conduct of the proceedings will be given in due course, including the overall length of the presentation of evidence allocated to each Party and to Victims' Counsel, as well as on other issues<sup>21</sup> and logistical matters.

#### IV. DISPOSITION

- 18. For the above-mentioned reasons, the Panel hereby:
  - a. DECIDES that the trial shall commence on Tuesday, 21 February 2023, at 09:30;
  - DECIDES that the SPO, Victims' Counsel and the Defence shall make their opening statements on Tuesday, 21 February 2023, at 09:30 and Wednesday, 22 February 2023, at 09:30, in accordance with paragraphs 8-11 of the present decision;
  - ORDERS the Defence to inform the Panel, by Friday, 10 February 2023, whether the Accused will make an unsworn statement directly before or after the Defence's opening statement and, if so, how much time he will require;
  - d. ORDERS the Parties and Victims' Counsel to file any motions within the meaning of Rule 117(2) of the Rules by Wednesday, 8 February 2023, with responses to be filed by Tuesday, 14 February 2023 and replies by Thursday, 16 February 2023, if any;
  - e. SETS the following dates for the first four evidentiary blocks, until the summer judicial recess, as follows: (i) Monday, 27 March 2023, at 09:30 to Friday, 31 March 2023; (ii) Monday, 1 May 2023, at 09:30 to Friday, 5 May 2023; (iii) Tuesday, 30 May 2023, at 09:30 to Friday, 9 June 2023; and (iv) Monday, 26 June 2023, at 09:30 to Wednesday, 28 June 2023 and Friday, 30 June 2023, at 09:30 to Friday, 7 July 2023; and
  - f. **ORDERS** the SPO to confirm by **Thursday**, **2 February 2023** the order of appearance of the first three SPO witnesses, as indicated in paragraph 16 of the present decision.
