A. INTRODUCTION

1. Pursuant to Articles 21 and 41 of the Law,¹ Rules 23(7) and 56(6) of the Rules,² Rule 43(3)(c) of the Rules of Detention,³ and in compliance with the request of the Trial Panel ('Panel'),⁴ the Specialist Prosecutor's Office ('SPO') hereby files its submissions on the Eighth Monthly Registry Report on segregation of the Accused ('Eighth Report').⁵

2. The SPO does not oppose changes to the segregation regime that may be necessary on medical grounds, and defers to the Trial Panel and the Registry for the appropriate measures in light of the specific circumstances of the case.

B. SUBMISSIONS

3. On 18 February 2022, the Panel issued its Second decision on the review of the segregation regime and other measures imposed on Salih MUSTAFA,⁶ whereby it decided to extend the Accused's segregation within existing parameters.⁷

4. As previously submitted by the SPO⁸ and found by the Panel, the continued segregation is warranted for the purpose of protecting victims and witnesses and/or their family members, in view of possible unlawful disclosure by the Accused of the identities of the SPO protected witnesses.⁹ Since the Second Segregation Decision no

circumstances known to the SPO have intervened capable of changing this assessment.

6. [REDACTED]. However, the SPO agrees that steps should be taken that are necessary to address relevant medical matters, and therefore does not oppose any necessary changes to the segregation regime based on medical grounds.

7. The SPO defers to the Trial Panel and the Registry for the appropriate measures to be taken in light of the specific circumstances of the case.
