## I. INTRODUCTION

1. Pursuant to Trial Panel I's ('the Panel') decision on the Specialist Prosecutor's request for segregation and other measures ('Segregation Decision'),<sup>1</sup> the Registrar submits the following report on the enforcement of the segregation regime and the system of communications restrictions and their effects on the Accused.

## II. PROCEDURAL HISTORY

1. On 19 August 2021, Mr Salih Mustafa ('Mr Mustafa') was segregated pursuant to the Segregation Decision.<sup>2</sup>

2. The conditions set out in the Segregation Decision were further clarified and amended through the Panel's decisions on 1 and 10 September 2021<sup>3</sup> and 19 November 2021.<sup>4</sup>

## III. SUBMISSIONS

3. In the Segregation Decision, the Registrar is ordered to submit a consolidated report every 30 days, as of 19 August 2021, or at any time earlier, if deemed necessary, on the enforcement of the segregation regime, restrictions on communications, and their eventual effects on the Accused, to the Panel, the Parties, and Victims' Counsel.<sup>5</sup>

4. The First Monthly Registry Report on Segregation of the Accused was filed on 20 September 2021.<sup>6</sup>
5. The Second Monthly Registry Report on Segregation of the Accused was filed on 20 October 2021.<sup>7</sup>
6. On 11 November 2021, the Panel issued an oral order requesting that the Third Monthly Registry Report on Segregation of the Accused be filed in advance of the deadline, by 16 November 2021.<sup>8</sup> Accordingly, the Third Monthly Registry Report on Segregation of the Accused was filed on 16 November 2021.<sup>9</sup>
7. The Fourth Monthly Registry Report on Segregation of the Accused was filed on 17 December 2021.<sup>10</sup>
8. The Registrar now presents the fifth report on: the implementation of the segregation regime (A), telephone calls (B), and visits (C) of the Accused, as well as the impact of such measures on him (D) since 17 December 2021 ('reporting period').

#### A. SEGREGATION REGIME

9. Mr Mustafa has been segregated in [REDACTED] the Detention Facilities since 19 August 2021, and he has had no contact with any other Detainees in the Detention Facilities. No breach of the segregation regime has been reported or noticed.
10. During his segregation, Mr Mustafa has had access to the facilities and services described in paragraphs 17-18 and 20-21 of the Registry Submissions,<sup>11</sup> including

access to privileged in-person visits, video visits, and telephone calls with Counsel and members of Counsel's Team.

11. Special attention continues to be paid to ensuring that Mr Mustafa has an opportunity for meaningful human contact for more than two hours per day through a combination of different avenues and activities.<sup>12</sup>

12. During the reporting period, Mr Mustafa has been visited daily by the Chief Detention Officer or a Detention Officer acting on his behalf, and he has also been visited by the Medical Officer, as described in paragraphs 24-25 of the Registry Submissions.<sup>13</sup>

13. In addition, during the reporting period, Detention Officers and other Detention Management Unit ('DMU') staff have proactively engaged with Mr Mustafa. [REDACTED].

14. DMU staff also made efforts to proactively engage additional person(s) in activities with the Accused.<sup>14</sup> [REDACTED].

17. The duration of the above interactions was influenced, *inter alia*, by the schedule of proceedings.

#### B. TELEPHONE CALLS

18. Based on the Segregation Decision, Mr Mustafa is permitted one (1) phone call per day with authorised family members, under active monitoring, for a maximum duration of 30 minutes per call. Calls are authorised from Monday to Friday during working hours, until 20:00 during hearing days, and between 10:00 and 17:00 on Saturdays and Sundays.<sup>15</sup> Following the Decision on Review of the Segregation

Regime, Mr Mustafa is permitted two (2) additional telephone calls per week with authorised family members, of 15 minutes each, on weekdays and during working hours only.<sup>16</sup> These restrictions are not applicable to privileged calls with Defence Counsel and his team or certain categories of special visitors.<sup>17</sup>

19. [REDACTED], Mr Mustafa has had [REDACTED] telephone calls [REDACTED] during the reporting period, which were actively monitored in accordance with the Segregation Decision.<sup>18</sup> No unauthorised disclosure was identified during the calls.

#### C. VISITS

20. Based on the Segregation Decision, Mr Mustafa is permitted a maximum of 10 visits per month, whether in-person or via video or a combination thereof, under active monitoring (in addition to the recording of all visits).<sup>19</sup> During hearing days, visits are authorised until 20:00.<sup>20</sup> Following the Decision on Review of the Segregation Regime, Mr Mustafa is permitted two (2) additional video visits per month.<sup>21</sup>

21. [REDACTED], Mr Mustafa had [REDACTED]<sup>22</sup> [REDACTED] during the reporting period, [REDACTED].

22. During the reporting period, Mr Mustafa [REDACTED].

23. All visits were actively monitored and recorded. No unauthorised disclosures were identified during the visits.
