TRIAL PANEL I (Panel), hereby renders this decision on lifting Salih Mustafa's restrictions on contacts and communications with the outside world.

I. PROCEDURAL BACKGROUND

- 1. On 2 August 2021, upon request of the Specialist Prosecutor's Office (SPO),¹ the Panel decided to segregate Salih Mustafa (Mr Mustafa) as of 19 August 2021 from the other accused persons in the Specialist Chamber's (SC) detention facilities and to impose restrictions on his contacts and communications with the outside world (Segregation Decision).²
- 2. On 10 September 2021,³ 19 November 2021⁴ and 19 May 2022,⁵ respectively, the Panel made certain modifications to the restrictions on Mr Mustafa's contacts and communications.
- 3. On 25 April 2022, the Panel decided to discontinue Mr Mustafa's segregation on [REDACTED] with immediate effect, but maintained the restrictions on his contacts and communications with the outside world.⁶

4. On 20 June 2022, the Panel closed the evidentiary proceedings in the present

case.7

5. On 20 July and 20 October 2022, respectively, the Panel decided to extend

the restrictions on Mr Mustafa's contacts and communications, subject to the same

conditions as set out in the Segregation Decision and any subsequent amendments

thereto.8

6. On 15 September 2022, the Presiding Judge declared the case closed at the

end of the hearing on closing statements.9

7. On 20 October 2022, the Panel decided to extend the restrictions on Mr Mustafa's

contacts and communications and set out a calendar for the Registry to submit

monthly reports.¹⁰

8. On 4 November and 2 December 2022, respectively, the Registry filed its latest

reports to the Panel, Parties and Victims' Counsel.¹¹

9. On 16 December 2022, the Panel pronounced in open court the judgment against

Mr Mustafa, convicting him for war crimes and sentencing him to 26 years of

imprisonment.¹² At the hearing, the Panel lifted proprio motu the restrictions on

II. APPLICABLE LAW

0. The Panel notes Article 8 of the European Convention on Human Rights (ECHR),

Article 22(2) of the Constitution of the Republic of Kosovo, Articles 3(2), 23(1), 40(2)

and (6), and 41(6)(b)(ii) of Law No. 05/L-053 on Specialist Chambers and Specialist

Prosecutor's Office and Rules 9(5), 56(3), 75(2) and 116(4)(d) of the Rules of Procedure

and Evidence Before the Kosovo Specialist Chambers (Rules).

III. ANALYSIS

11. The present decision offers the written reasons for terminating the restrictions of

Mr Mustafa's contacts and communications with the outside world, as required by

Rule 75(2) of the Rules.

2. At the outset, the Panel recalls the general principles guiding the assessment of

the compatibility of restrictions on contacts and communications with Article 8 of the

ECHR. In particular, pursuant to Article 8(2) of the ECHR, the measures put in place

must be: (i) "in accordance with the law"; (ii) necessary and (iii) proportionate to the

legitimate aim pursued.¹⁴

13. The Panel has been restricting Mr Mustafa's contacts and communications with

the outside world in accordance with the applicable law before the SC for reasons set

out first in the Segregation Decision and further detailed in subsequent decisions.¹⁵

14. The aim of protecting the witnesses and victims in this case and their families

remains of paramount importance to the Panel, even after the pronouncement of the

judgment which imposed a custodial sentence on Mr Mustafa. That being said, while

the risk persists that Mr Mustafa may interfere with victims and witnesses, and/or

their families,16 sufficient measures remain in place, which provide adequate

safeguards against this risk. These include: (i) the continued imprisonment of

Mr Mustafa, following his sentencing; (ii) the default passive monitoring of all

non-privileged telephone conversations, the supervision of all non-privileged

in-person and video visits, as well as the security controls in place for all

non-privileged correspondence;17 (iii) the protective measures regime in place to

protect witnesses and victims participating in the proceedings; and (iv) the continuous

obligation of Mr Mustafa not to divulge any identifying information of the protected

witnesses or any other confidential information contained in the case file or any other

proceedings before the SC to anyone outside of his defence team.¹⁸ The Panel's

conviction is further strengthened by the recent Registry's submissions, suggesting

that no unauthorised disclosure of confidential information by Mr Mustafa to the

outside world was identified either during the calls or during the visits while restrictions on contacts and communications were in place.¹⁹

15. Regarding the proportionality of such restrictions, the Panel also recalls that in the context of the present proceedings, Mr Mustafa has been segregated from other detainees for over 8 months (from 19 August 2021 until 25 April 2022), and that his contacts and communications with the outside world have so far been restricted for a total duration of over 16 months (from 19 August 2021 until the present time). The combined effect of detention in segregation and restrictions of Mr Mustafa's contacts and communications with the outside world represents a considerable limitation of his rights to privacy and family life. With the passage of time, such a limitation becomes less proportionate. The Panel considers that, at this stage of proceedings, and considering the availability of other safeguards in place, the restrictions of Mr Mustafa's contacts and communications are no longer proportionate to the legitimate aim pursued.

16. In light of the above, the Panel finds that the current restrictions on Mr Mustafa's contacts and communications shall be lifted effective **Wednesday**, **21 December 2022**, **at noon**, and that the Registry shall take any necessary steps to this effect.

IV. DISPOSITION

- 17. For the above-mentioned reasons, the Panel hereby:
 - a. **RECALLS** its decision of 16 December 2022, to lift *proprio motu* the restrictions on Mr Mustafa's contacts and communications with the outside world currently in place, effective **Wednesday**, **21 December 2022**, **at noon**; and
 - b. **ORDERS** the Registry to take all necessary steps to implement the present decision.
