1. On 26 January 2023, the Trial Panel ordered¹ the Specialist Prosecutor's Office

('SPO') to confirm the order of appearance of the first three SPO witnesses.

2. The SPO confirms that the order of appearance of the first three SPO witnesses

remains [REDACTED], as indicated in the Witness List filed on 10 October 2022.² In

addition, the SPO confirms its intention to call [REDACTED] as the fourth witness.

3. [REDACTED]. [REDACTED] the SPO considers it preferable if they could be

examined in the same evidentiary block. [REDACTED].

4. Considering the limited courtroom availability, the SPO considers it important

to endeavour to maximise the use of available courtroom time, consistent with the

requirements of a fair and expeditious trial. In this respect, the SPO has reassessed and

reduced its estimates for the duration of these witnesses' examinations-in-chief, as

indicated in Annex 1 to this submission.

5. Based on the foregoing, the SPO intends to call [REDACTED], during the first

evidentiary block of the trial, scheduled from Monday, 27 March 2023 to Friday, 31

March 2023.

6. Finally, in light of the evidentiary blocks set out in the Scheduling Decision,³

the SPO has revised the tentative order of appearance of its other witnesses. The

updated order of witnesses is reflected in the witness list attached in Annex 1 to this

submission. [REDACTED].

7. This submission is filed as confidential as it refers to witness information not

publicly available. A public redacted version will be filed.
