1. Pursuant to the Order on the Conduct of Proceedings,¹ the Specialist Prosecutor's Office ('SPO') hereby submits a supplemental notice under Rule 102(3) of the Rules ('March 2023 Notice').²
2. The March 2023 Notice reflects items falling under Rule 102(3) which have been identified, obtained, or cleared since the date indicated in the February 2023 Notice,³ up until 3 March 2023.⁴ As previously submitted, the SPO will continue to discharge its obligations under Rule 102(3), including as additional items falling within the scope of the rule are obtained or cleared.⁵
3. The March 2023 Notice is confidential in accordance with Rule 82(4), to give effect to applicable confidentiality restrictions and protective measures, and for the protection and privacy of the individuals identified therein.
