THE PRESIDENT of the Specialist Chambers ("President"), noting Articles 33(1)(c) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, Rules 113(6) and 169 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers and Rules 3 and 4 of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns a Court of Appeals Panel to decide on the "Victims' Counsel Submissions Pursuant to Article 22(6) of the Law No.05/L-053"¹ ("Submissions"), the "Victims' Counsel Appeal on Fourth Decision on Victims' Participation"² and the "Appeal of Victim 24/06 against the 'Fourth Decision on Victims' Participation' Pursuant to Rule 113(6) of the Rules with Strictly Confidential and *Ex Parte* Annexes 1 to 7"³ (collectively, "Appeals").

I. PROCEDURAL BACKGROUND

1. On 12 December 2022, the Pre-Trial Judge rendered the "Fourth Decision on Victims' Participation" ("Impugned Decision"), wherein he, *inter alia*, rejected the applications of certain individuals who sought to participate as victims in the current proceedings.⁴

2. On 13 February 2023, Counsel for denied applicant 24/06 filed an Appeal. On 28 February and 2 March 2023, Counsel for 19 denied applicants filed the Submission
