1. Pursuant to the Decision<sup>1</sup> and Rule 95(4) of the Rules,<sup>2</sup> the Specialist Prosecutor's Office ('SPO') hereby: (i) files an amended exhibit list ('Amended List');<sup>3</sup> and (ii) identifies the additional relevant information contained in statements [REDACTED].<sup>4</sup> Pursuant to the Framework Decision,<sup>5</sup> Articles 23, 35(2)(f), and 39(1), (3) and (11) of the Law<sup>6</sup> and Rules 80, 95(2)(h), and 108, the SPO also requests authorisation to apply a further non-standard redaction to document [REDACTED], which is necessary to give effect to existing protective measures for [REDACTED].

2. The Amended List includes the following modifications:

- a. addition<sup>7</sup> of: (i) the Further Material,<sup>8</sup> as authorised in the Decision;<sup>9</sup> and (ii)
  other language versions of documents already on the Exhibit List;<sup>10</sup>
- b. certain corrections to ERNs, descriptions, and metadata;<sup>11</sup> and

c. removal of four duplicate entries.<sup>12</sup>

3. In the Decision, the Pre-Trial Judge authorised the SPO to apply non-standard redactions to [REDACTED].<sup>13</sup> Upon closer review of [REDACTED], including against the typed transcript,<sup>14</sup> the SPO has identified one additional sentence which requires non-standard redactions.<sup>15</sup> This sentence relates to information which is contained in the following portion of the document and for which non-standard redactions have already been authorised in the Decision. The proposed additional non-standard redaction is therefore necessary to give effect to existing protective measures.

4. This filing and Annexes 2 and 3 are confidential and Annexes 1, 4 and 5 are strictly confidential and *ex parte* pursuant to Rule 82(4).
