Defence Request for an Extension of Time for its Response to the Prosecution Motion for Judicial Notice of Facts of Common Knowledge and

- Pursuant to Rules 9(5)(a) and 76 of the Rules of Procedure and Evidence before the Kosovo Specialist Chambers ("Rules"), the Defence for Mr Pjetër Shala ("Defence") submits this request for a 10-day extension to file its Response to the Prosecution Motion for Judicial Notice of Facts of Common Knowledge and Adjudicated Facts.¹
- 2. There is good reason to grant the requested extension. The complexity of the issues set out in the Motion as well as the number of proposed facts of common knowledge and adjudicated facts in its Annexes require careful analysis and consideration. In addition, the Defence is at present focused on preparing for the second evidentiary block, and must address important competing procedural obligations.²
- 3. The requested variation would allow the Defence sufficient time to present effective submissions that will assist the Trial Panel in its determination of the relevant issues at stake. No prejudice will be caused by the proposed extension.
- 4. This Request is filed as confidential, pursuant to Rule 82(3) of the Rules, as it relates to confidential filings. The Defence seeks leave to reclassify it as public in due course as it contains no confidential information.
