**TRIAL PANEL II** ("Panel"), pursuant to Article 40(2) and (6)(h) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office, and Rules 9(5)(a) of the Rules of Procedure and Evidence Before the Kosovo Specialist Chambers, hereby renders this decision.

## I. PROCEDURAL BACKGROUND

- 1. On 8 March 2023, the Specialist Prosecutor's Office ("SPO") filed a motion for the admission of the Accused's statements ("Motion").<sup>1</sup>
- 2. On 10 March 2023, the Defence for Hashim Thaçi, Rexhep Selimi, and Jakup Krasniqi jointly filed a request for additional time to respond.<sup>2</sup>
- 3. On 16 March 2023, the Panel granted the Defence's request.<sup>3</sup>
- 4. On 17 April 2023, during a hearing, pursuant to a request from the Defence for Hashim Thaçi,<sup>4</sup> the Panel granted an additional extension of time to all Defence teams to respond to the Motion.<sup>5</sup>
- 5. On 24 April 2023, the Defence for Hashim Thaçi, Kadri Veseli, Rexhep Selimi, and Jakup Krasniqi ("Defence") filed responses to the SPO's Motion.<sup>6</sup>

6. On 26 April 2023, the SPO filed a request for an extension of the time limit to reply to the Defence's responses ("Request").<sup>7</sup>

## II. DISCUSSION

- 7. Pursuant to Rule 76, a Party or participant must file a reply, if any, within five days of the response. The Panel may grant an extension where the application comes sufficiently in advance to enable the Panel to rule on the application before the expiry of the relevant time limit. Pursuant to Rule 9(5)(a), the party seeking additional time must demonstrate good cause for an extension.
- 8. As regards the timeliness of the Request, the Panel notes that the Request was filed sufficiently in advance of the deadline.
- 9. As regards the good cause requirement, the SPO submits that the Request will not prejudice the Defence, will enable focused and streamlined replies, and will ultimately facilitate the Panel's consideration of the Motion. In particular, the Defence's responses raise new, complex legal and factual issues, including concerning the manner in which the proposed statements were taken and the procedure and purported limits on admission. Finally, the SPO submits that the number and volume of statements concerned and competing deadlines, which previously justified extensions of time for the Defence, also militate in favour of the Request.<sup>8</sup>
- 10. For the reasons submitted by the SPO, and further noting that the Defence did not oppose the Request, the Panel finds that the good cause requirement is met under the circumstances. Moreover, the Panel considers that the proposed extension of one week<sup>9</sup> (i.e., until 8 May 2023) is reasonable.
