- 1. Pursuant to Rule 9(5) of the Rules,¹ the Specialist Prosecutor's Office ('SPO') requests a two-week extension of the 24 May 2023 deadline for its Brief in Response to the Appeal Brief.² The requested extension is: (i) timely, considering that the Appeal Brief was notified on 24 April 2023; and (ii) reasonable and proportionate, including in light of the two extensions of time granted the Defence, resulting in a total of 38 additional days to prepare the Appeal Brief.³
- 2. There is good cause for the requested extension, which will not prejudice the Defence, will enable a focused and streamlined response, and will ultimately facilitate the Panel's consideration of the Appeal. In particular, the Appeal Brief raises over 50 legal and/or factual basis of appeal, some of which address complex or novel issues before the court. In this respect, the previously granted Defence extensions also militate in favour of this request, noting that the Appellant has had the benefit of more than five weeks additional time to prepare the Appeal Brief. Finally, unstructured, unclear and unsubstantiated submissions in the Appeal Brief which in some cases depart from the notified grounds add further difficulty to the Prosecution's task in identifying the points at issue and filing focused, clear and substantiated submissions in response.
