
## I. INTRODUCTION

1. The Specialist Prosecutor's Office ('SPO') requests authorisation to replace eight documents – with correct and revised versions –tendered in the First Rule 155 Motion.<sup>1</sup>

## II. SUBMISSIONS

2. In the First Rule 155 Motion, the SPO sought admission of the prior statement and associated exhibits of W02618.<sup>2</sup> On 4 May 2023, following a review of these documents, the SPO disclosed revised Albanian versions of Parts 1 to 4 and revised English versions of Parts 2 to 4 of the transcript of W02618's prior statement—his SPO interview—and a revised English translation of one associated exhibit.<sup>3</sup> The revisions have no impact on any of the SPO's submissions in relation to this witness. The SPO requests that the Trial Panel authorise the replacements, in the terms set out above, and admit the revised transcripts and associated exhibit pursuant to Rule 155.<sup>4</sup>
