1. On 8 March 2023, the Specialist Prosecutor's Office ('SPO') sought admission of the records of certain interviews and prior testimony of the Accused as listed in Annex 1 to the Motion ('Annex).<sup>1</sup> The SPO has identified that the Albanian translation of one statement,<sup>2</sup> and the English translations of certain associated exhibits,<sup>3</sup> were inadvertently omitted from the Annex. In the annex to this filing, the SPO lists the translations which it seeks to additionally tender. The items being added are all translations of items which were previously identified in the Annex, and all of them have were previously disclosed under Rule 102(1).

2. Pursuant to Articles 37 and 40 of the Law<sup>4</sup> and Rules 137 and 138 of the Rules,<sup>5</sup> the SPO requests the Panel to admit into evidence the translations listed in Annex 1 to this supplement, in addition to the materials previously identified in the Annex.
