

1. Pursuant to Rules 82 and 95(4) of the Rules,¹ the Specialist Prosecutor's Office hereby files an Amended Witness List² and a confidential lesser redacted version of the Pre-Trial Brief.³
2. The Amended Witness List reflects modifications to modes and hours of testimony previously communicated,⁴ the deceased status of four witnesses,⁵ and corrections to the summary for W04323.
3. Further, as the identities of additional witnesses who previously benefitted from delayed disclosure protective measures have been disclosed to the Defence, related redactions have been removed from the confidential versions of the Amended Witness List and Pre-Trial Brief.⁶
4. Annex 1 is strictly confidential and *ex parte*, and Annexes 2-3 are confidential pursuant to Rule 82(4) and to give effect to existing protective measures.
