1. Pursuant to the Decision¹ and Rules 82-84 of the Rules,² the Specialist Prosecutor's Office ('SPO') has reviewed the classification of the Admitted Items and filing F00095.³ As indicated in Annex 1:⁴
 - a. 75 Admitted Items can be reclassified as public by the Registry; and
 - b. 8 Admitted Items must remain confidential to: (i) give effect to existing protective measures and to avoid the identification of SPO witnesses and victims whose identities are not public; and (ii) safeguard the public interest or rights of third parties.
2. In addition, as indicated previously,⁵ the SPO does not object to the reclassification of filing F00095 and its annexes⁶ as confidential, subject to any redactions to personal information, including of family members, considered necessary by the KRASNIQI Defence.
3. Annex 1 is confidential to give effect to existing protective measures.
