Pursuant to Article 26(2) of the Practice Direction,<sup>1</sup> the Specialist Prosecutor's Office ('SPO') hereby withdraws its Rule 107(2)<sup>2</sup> request relating to [REDACTED].<sup>3</sup> As noted in the Motion, the clearance request for, among others, [REDACTED] was pending with relevant Rule 107 provider(s) at the time the Motion was filed.<sup>4</sup> Thereafter, the SPO received the unredacted version ([REDACTED]) without Rule 107 conditions.<sup>5</sup> The unredacted version has since been disclosed,<sup>6</sup> rendering the SPO's Rule 107(2) request in relation to [REDACTED] moot.
