THE PRESIDENT of the Specialist Chambers ("President"), noting Article 33(3) of Law No. 05/L-053 on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rules 3 and 4(2) of the Rules on the Assignment of Specialist Chambers Judges from the Roster of International Judges ("Rules on Assignment"), herewith assigns a Constitutional Court Panel to rule on the "Referral to the Constitutional Court Panel Concerning the Violation of Mr Shala's Fundamental Rights Guaranteed by Articles 31, 32, and 54 of the Kosovo Constitution and Articles 6 and 13 of the European Convention on Human Rights" ("Referral").1

I. PROCEDURAL BACKGROUND

- 1. On 6 December 2022, the Trial Panel issued the "Corrected version of Decision Concerning Prior Statements given by Pjetër Shala" ("Impugned Decision") wherein it, inter alia, denied Mr Pjetër Shala's request to have his prior statements to the Belgian Federal Judicial Police in 2016 declared inadmissible in the current proceedings.²
- 2. On 13 December 2022, Mr Shala requested leave to appeal the Impugned Decision,³ which was granted by the Trial Panel on 24 January 2023.4
- 3. On 13 February 2023, Mr Shala appealed the Impugned Decision ("Appeal").⁵

- 4. On 5 May 2023, the Court of Appeals Panel granted the Appeal, in part, but nevertheless held that Mr Shala's statements given in 2016 "are not inadmissible".6
- 5. On 18 May 2023, Mr Shala filed a request for reconsideration of the Impugned Decision ("Request for Reconsideration").⁷
- 6. On 23 May 2023, the Trial Panel rejected the Request for Reconsideration.8
- 7. On 11 July 2023, Mr Shala filed the Referral.

II. ASSIGNMENT

- 8. Pursuant to Article 33(3) of the Law, upon a referral to the Specialist Chamber of the Constitutional Court ("SCCC"), the three Judges of the SCCC shall be assigned. Should one of these Judges not be available for assignment, the President shall assign the reserve constitutional judge.
- 9. The President notes that one of the three Judges of the SCCC is not available for assignment. Accordingly, the President shall assign the reserve constitutional Judge, in accordance with Article 33(3) of the Law and Rule 4(2) of the Rules on Assignment.

III. **CLASSIFICATION**

10. The Referral is classified as confidential and the present decision will therefore bear the same classification in accordance with Rule 82(4) of the Rules, until it is reclassified in due course consistent with Rule 3(4) of the Rules on Assignment.
