- 1. Pursuant to the Order on the Conduct of Proceedings,¹ the Specialist Prosecutor's Office ('SPO') hereby submits a supplemental notice under Rule 102(3) of the Rules² ('July 2023 Notice').³
- 2. The July 2023 Notice includes items falling under Rule 102(3) which have been identified, obtained, or cleared since the date indicated in the June 2023 Second Notice,⁴ up until 30 June 2023. For the record, the Notice lists four items recently obtained, which have already been disclosed to the Defence in light of W04746's imminent testimony.⁵ As previously submitted, the SPO will continue to discharge its obligations under Rule 102(3), including as additional items falling within the scope of the rule are obtained or cleared.⁶
- 3. The July 2023 Notice is confidential in accordance with Rule 82(4), to give effect to applicable confidentiality restrictions and protective measures, and for the protection and privacy of the individuals identified therein.
