Order Scheduling an Appeal Hearing

THE PANEL OF THE COURT OF APPEALS CHAMBER of the Kosovo Specialist Chambers ("Court of Appeals Panel", "Appeals Panel" or "Panel" and "Specialist Chambers", respectively),¹ acting pursuant to Article 33(1)(c) of the Law on Specialist Chambers and Specialist Prosecutor's Office ("Law") and Rule 172 of the Rules of Procedure and Evidence ("Rules"), hereby issues this Order.

1. The Panel notes that Rule 180 of the Rules provides that, "[a]fter the expiry of the time limits for the filing of the briefs provided for in Rule 179, the Court of Appeals Panel may set the date of an appeal hearing, if necessary."²

2. On 16 June 2023, the briefing was completed regarding Mr Salih Mustafa's ("Mustafa") appeal against the Trial Judgment issued in KSC-BC-2020-05.³ Taking into consideration the specific circumstances of this case, the Panel is satisfied that an appeal hearing is necessary and hereby schedules it for **Thursday**, **26 October 2023 at 13:30** and **Friday**, **27 October 2023 at 9:30**.

3. Moreover, subject to adjustments as appropriate, the schedule for the Appeal Hearing shall be as follows. The Panel notes in this regard that the time allocated for

the submissions, responses and reply includes any questions from the Panel which may arise during the hearing.

11:00-11:05 – Concluding statement by the Presiding Judge (5 minutes)

4. Finally, in accordance with Rules 68 and 173(3) of the Rules, the Panel instructs the Defence to indicate via email to the Court Management Unit, by **Monday**, **16 October 2023 at 16:00**, whether the Accused wishes to participate in the Appeal Hearing, and/or whether the Accused wishes to appear via video-conference. If the Accused does not wish to participate in the Appeal Hearing, the Defence should submit the pertinent waivers, in the same manner and by the same date and time.

5. For these reasons, the Court of Appeals Panel:

SCHEDULES the Appeal Hearing for Thursday, 26 October 2023 at 13:30 and Friday, 27 October 2023 at 9:30; and

INSTRUCTS the Defence to indicate, by **Monday**, **16 October 2023 at 16:00**, and in the manner set out above at paragraph 4, whether the Accused wishes to participate in the Appeal Hearing and, if necessary, submit the pertinent waivers.
