I. INTRODUCTION

1. The Specialist Prosecutor's Office ('SPO') opposes the Joint Defence Request for Reclassification of Filing F01636 ('Request').¹ Filing F01636 contains non-public information about a protected witness.² For that reason, the Defence should be required to file a public redacted version of F01636, as ordered by the Panel,³ with appropriate redactions as explained below. In addition, the SPO requests further redaction of F01647/RED.⁴

II. SUBMISSIONS

- 2. The Defence response to the relevant Rule 154 application (F01636) concerns two SPO witnesses, including W04586. This witness testified with protective measures.⁵ The Defence response contains the following details, which may tend to reveal his identity: (i) [REDACTED], and (ii) [REDACTED].⁶ Redactions are therefore required to maintain the effectiveness of his protective measures.⁷
- 3. On 21 July 2023, the Defence filed a public redacted version of F01647/RED.⁸ The public redacted version contains information about witnesses who have not yet

testified, which should be redacted from the public.⁹ This includes the fact of [REDACTED]¹⁰ including with specific mention of the fact of [REDACTED].¹¹

4. Finally, the Defence redactions reveal the gender of certain protected witnesses. Pursuant to the Panel's request,¹² the SPO has engaged in *inter partes* communications with the Defence in respect of the necessity for gender neutral language for certain witnesses. On 21 July 2023, having considered the security and privacy concerns of the witnesses in the next group of witnesses, the SPO informed the Defence that it requested that gender neutral language be used for [REDACTED].¹³ The SPO requests further redactions to the Defence's submissions on this witness to remove all language which identifies the witness's gender.

III. RELIEF REQUESTED

5. For the foregoing reasons, the SPO respectfully requests that the Panel: (i) reject the Defence request to re-classify F01636, (ii) maintain its order to the Defence to file a public redacted version of F01636, and (iii) order the Defence to make further redactions to F01647, including to ERNs, in accordance with the criteria explained herein.

Similarly, witnesses who are expected to testify publicly may request protective measures at any time before they testify. For example, while the SPO anticipated that W03165 and W03540 would testify without protective measures, both witnesses requested and were granted protective measures on the eve of testimony. For all witnesses, their privacy and security interests are best protected if information which could tend to identify them remains confidential until the time of their testimony.
