

1. Pursuant to the Fifth Decision¹ and Rules 82-84 of the Rules,² the Specialist Prosecutor's Office ('SPO') has reviewed the classification of the exhibits admitted through the Fifth Decision.³ The SPO confirms that the admitted exhibits, along with their corresponding translations, currently classified as confidential can be reclassified as public.

2. In addition, for the record and while it does not impact the Panel's reasoning for the admission of these items,⁴ the SPO notes that U000-0531-U000-0531⁵ and U000-9953-U000-9953⁶ were not seized from Jakup KRASNIQI's or Rexhep SELIMI's residences, unlike the remaining exhibits admitted in the Fifth Decision.
