I. INTRODUCTION

1. The Response¹ does not engage with the purposes of the Request, namely, to ensure W01493's health and well-being, and to facilitate his testimony in an expeditious manner.² Instead, the Response relies on unsubstantiated assertions concerning the Request's timing and alleged prejudice, which should be dismissed.

II. SUBMISSIONS

- 2. Despite Defence arguments otherwise,³ the Request was made in a timely manner in light of W01493's current circumstances, following consultations with the relevant authorities, and sufficiently in advance of his testimony.⁴
- 3. Further, the Defence's 'strong preference' for W01493 to be brought to The Hague⁵ is wholly inadequate to undermine the well-founded medical, security, and related grounds underlying the Request. As previously held by the Panel, video-conference testimony, in and of itself, does not prejudice the Defence.⁶ The Panel and Parties will be able to observe and question the witness, and the Panel will be able to adequately instruct the witness, assess his demeanour, and control the proceedings.⁷

III. CLASSIFICATION

4. This filing is confidential pursuant to Rule 82(4) of the Rules.⁸ The SPO does not object to its reclassification as public.
