Registrar's Submissions on (Re)classification of Filings Pursuant to F00083

1. The Pre-Trial Judge ordered the Registrar to indicate whether certain filings can be reclassified as public and/or confidential, and the *ex parte* markings lifted, as the case may be, or to submit reasons for maintaining their current classification by Monday, 6 November 2023.¹ Pursuant to the Pre-Trial Judge's Order, the Registrar hereby makes the following submissions.
2. The Registrar has no objection to filings F00011, F00012, F00014, F00015, F00018, and F00019 being reclassified as public, as the reasons underlying their initial classification as strictly confidential and *ex parte* no longer exist.
3. The Registrar will submit, according to the deadlines set in the Order, public redacted versions of F00014/A01 and F00015/A01, after redacting certain identifying information of Registry staff. The Registrar will also submit public redacted versions of F00020/COR and F00021, in accordance with the Order.²
4. The Registrar will submit confidential and *ex parte* redacted versions of F00020/A01, F00020/A02, F00020/A03, F00021/A01, F00021/A02, F00021/A03. The redactions are necessary to protect the identifying information of staff of the Specialist Prosecutor's Office and/or the Registry. Additionally, the *ex parte* status is needed, as the filings contain private information relating to each of the Accused that should only be accessible to their respective Defence Counsel.
5. Finally, the Registrar has no objection to F00066 being reclassified as confidential, provided that the submissions referenced therein are similarly reclassified. The Registrar submits that F00066 is not suitable for reclassification as public, as it contains internal information related to operations of the Registry that is not suitable for public dissemination.
