
The Specialist Prosecutor, pursuant to Articles 35(2) and 41 of Law No.05/L-053 on Specialist Chambers and Specialist Prosecutor's Office ('Law'), as well as Rule 52 of the Rules of Procedure and Evidence before the Specialist Chambers, hereby issues this:

ORDER FOR ARREST OF ISNI KILAJ
born 19 December 1963

There is grounded suspicion that Mr KILAJ is criminally responsible for committing either alone, or in co-perpetration with others, offences within the jurisdiction of the Kosovo Specialist Chambers, including obstructing official persons in performing official duties within the meaning of Article 401 of the 2019 Kosovo Criminal Code, Code No.06/L-074 ('KCC') and violating secrecy of proceedings under Article 392 of the KCC, and Articles 15(2) and 16(3) of the Law.

Mr KILAJ's arrest is necessary under Article 41(6)(b) of the Law, there being articulable grounds to believe he is a flight risk, he will hide or destroy further evidence, and/or he will obstruct the progress of investigations and criminal proceedings before the Kosovo Specialist Chambers.
