1. Pursuant to the First Rule 153 Decision¹ and Rules 82-84 of the Rules,² the Specialist Prosecutor's Office ('SPO') has reviewed the classification of the exhibits admitted through the First Rule 153 Decision.³ The SPO confirms that the admitted statements and associated exhibits of protected witnesses W01237, W04871, W04872, and W04673, along with their corresponding translations, which are currently classified as confidential, should remain confidential to give effect to the witnesses' court-ordered protective measures.
2. The confidential version of W04594's ICTY testimony (IT-04-84bis P00051 Confidential; IT-04-84 T4786-T4899 unredacted Parts 1-2), SPO interview (091401-TR-ET Parts 1-3; 091401-TR-AT Parts 1-3 Revised), and statement with ERN U007-9712-U007-9717 (U007-9712-U007-9717-AT), should remain confidential to give effect to provider-applied restrictions and the protective measures of [REDACTED], who is identified therein.
3. The SPO does not object to the public reclassification of the remaining materials admitted by the First Rule 153 Decision: W04592's admitted statements, W04594's statement with ERN U016-2063-U016-2063, the public version of W04594's ICTY testimony (IT-04-84bis P00050), and the associated exhibit with ERN IT-04-84 D00089.
4. This filing is confidential pursuant to Rule 82(4) and to give effect to existing protective measures.
