1. The Selimi Defence ("the Defence") will file a request for certification to appeal

the Trial Panel's Decision on Prosecution Motion for Admission of Accused's

Statements ("the Decision") by the 27th of November 2023, pursuant to the Trial

Panel's Oral Order of 13 November 2023.² Pursuant to Article 36(1) of the Practice

Direction,³ the Defence respectfully requests an extension of 2,000 words to a

total of 5,000 words for the filing in question.

2. In light of the fact that (i) the Decision spans almost 120 pages, more than a

quarter of which concern exclusively evidence related to Mr. Selimi; and (ii) the

Decision addresses intricate questions of law and fact of particular importance

to the present proceedings, good cause exists for the requested word extension.
