- 1. Pursuant to the Decision,¹ the Specialist Prosecutor's Office ('SPO') hereby proposes certain reductions to the Decision before it is made available to the Accused, or public.
- 2. The redactions required for making the Decision available to the public are marked in Annex 1. A number of the proposed redactions to the public redacted version of the Decision aim to prevent the public from identifying and further disseminating the identity of a victim/witness, which would [REDACTED] at additional risk of harassment and physical harm and also have a chilling effect on [REDACTED] current and potential witnesses of the Kosovo Specialist Chambers ('KSC').² The risk to these individuals is real, particularly in light of the pervasive climate of fear and intimidation in Kosovo against witnesses and potential witnesses of the KSC.³
- 3. The SPO also proposes temporary redactions regarding:⁴
 - a. [REDACTED];5 and
 - b. [REDACTED].6
- 4. A limited number of proposed redactions contain personal identifiable information, namely, telephone numbers,⁷ or [REDACTED].⁸

5. The risks of including the information contained in the proposed redactions far

outweigh the public interest in publishing the information, at this stage, especially

since the underlying criminal conduct charged in the Confirmed Indictment will be

clear to the public from the unredacted portions of the charging document.

6. With regard to making the filing available to the Defence, 9 only one redaction

is required (which also applies for the public). [REDACTED].¹⁰

7. This filing and its annex are submitted as strictly confidential and *ex parte* in

accordance with Rule 82(4).
